The purpose of this filing is to clarify the responsibilities regarding the installation, ownership, maintenance and replacement of service lines to non-residential customers, including service lines to multi-family residential structures and service lines within mobile home parks. This filing is being submitted in part in response to a dispute that recently arose with a mobile home park owner with respect to such responsibilities. That dispute resulted in a formal Complaint And Petition For Declaratory Order that is currently pending before the Commission in Docket No. UE-051828. In the event the Commission wishes to suspend these proposed tariff revisions for further investigation, the Company suggests that these proposed revisions be consolidated with Docket No. UE-051828.

The tariff sheets described herein reflect issue dates of December 19, 2005, and effective dates of January 19, 2006. Posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being given to the public immediately prior to or coincident with the date of this transmittal letter, through web, telephone and mail access in accordance with WAC 480-100-193. Notice of proposed tariff changes, as required by law and the Commission's rules and regulations, is being given to the public in accordance with WAC 480-100-195(3), immediately prior to or coincident with the date of this transmittal letter through posting in accordance with WAC 480-100-193(1). As a courtesy, PSE is also providing a copy of this filing to the attorney representing the complainant/petitioner in Docket No. UE-051828.
