Westgate Communications LLC, (WeavTel) hereby respectfully requests that it be designated as an Eligible Telecommunications Carrier (ETC) for the proposed new exchange of White River. The White River exchange is near Lake Wenatchee and currently is not serviced by any telecommunications company. The White River Exchange borders Verizon territory. Please see the attached map of the proposed exchange area.

WeavTel is duly authorized company to do business in the state of Washington and is a Washington Limited Liability Company with offices in Chelan Washington. WeavTel has designation as a Competitive Local exchange Carrier from the WUTC and a currently has ETC standing for the Local Exchange of Stehekin Washington.

For the purposes of this request, WeavTel is a Local Exchange carrier acting as the incumbent carrier.

Weavtel will meet the requirements of 47 U.S.C Sec. 214(e) and offer its services throughout the service area for which it is designated and will advertise the availability of service through media of general distribution.

Weavtel will provide the services required by 47 C.F. R Sec. 54.101; and 54.405 through 411.

WeavTel will serve this area by constructing it's own wire center and will seek support from several support programs for high cost service areas.

WeavTel will provide toll blocking as needed to customers in this exchange that wish this service and customers that request toll blocking will not be required to pay a deposit.
