This is to advise you that the North Beach Public Development Authority (the "PDA"), a public corporation created by Pacific County, Washington, has acquired substantially all of the assets of Ocean Park Water Company, Inc. ("OPWC") and OPWC is in the process of being dissolved.

The transfer of OPWC assets to the PDA occurred by bill of sale (dated March 13, 2006) and statutory warranty deed (dated March 16, 2006), copies of which are enclosed. OPWC ceased doing business as of March 31, 2006, and the PDA will from and after April 1, 2006 be providing water service to all former customers of OPWC. As a public corporation created by Pacific County, the PDA is exempt from regulation by the WUTC.

# BILL OF SALE AND ASSIGNMENT

THIS BILL OF SALE AND ASSIGNMENT (this "Bill of Sale and Assignment") is delivered pursuant to the resolutions adopted by the Board of Directors and the shareholders of Ocean Park Water Company, Inc. (the "Company") on March 6, 2006.

#### RECITALS

- A. Pursuant to the resolutions referenced above, and in connection with the dissolution and winding up of the Company, the Company has agreed to distribute, convey, transfer, assign and deliver to Ocean Park Acquisitions, LLC all of the assets of the Company listed in <a href="Exhibit A">Exhibit A</a> (the "Distributed Assets"). Ocean Park Acquisitions, LLC is the Company's largest shareholder. North Beach Public Development Authority is the sole member of, and owns all of the membership interests of, Ocean Park Acquisitions, LLC.
- B. Ocean Park Acquisitions, LLC has directed that all instruments of conveyance with respect to the Distributed Assets, including this Bill of Sale and Assignment, and any other endorsements, assignments, and other instruments contemplated by the dissolution of the Company, be made in favor of, and executed and delivered by the Company directly to, North Beach Public Development Authority.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Company hereby agrees as follows:

# 1. Sale and Assignment

The Company hereby grants, bargains, conveys, assigns and delivers to North Beach Public Development Authority, all right, title and interest in and to the Distributed Assets, subject to all liens, claims, charges and encumbrances, of any type whatsoever.

# 2. Company's Consent

The Company hereby covenants and agrees that it will, at the reasonable request and expense of North Beach Public Development Authority, execute and deliver, and will cause to be executed and delivered, such further instruments of sale, transfer, conveyance and assignment and take such other action as may reasonably be required to more effectively sell, transfer, convey, assign and deliver to, and vest in, North Beach Public Development Authority, its successors and assigns title to and possession of the Distributed Assets, and to put North Beach Public Development Authority in actual possession of the Distributed Assets.

# 3. Applicable Law

This Bill of Sale and Assignment shall be governed by, and construed and interpreted in accordance with, the laws of the State of Washington.

I would like to introduce myself—I am R. D. Williams, a resident of Ocean Park and President of the North Beach Development Authority, a public entity with a five-member board created by the Pacific County Commissioners in October 2004. Other Board members include Tom Downer, Jim Hagen, Ken Karch, and Brad Weatherby.

The North Beach Public Development Authority is purchasing the facilities of Ocean Park Water and Pacific Water Companies. For the time being, the new water utility will be operated as **North Beach Water**.

Water is a critical resource for any community, and water systems are often a take-over target for private enterprise. When a private company buys a public water system, the control of this precious commodity is often taken out of local hands. We didn't want that to happen.

Combining the facilities of these two water systems will result in a publicly-owned water utility serving over 2,200 residences and 300 businesses in the area between Cranberry Road, Joe Johns Road, the Pacific Ocean, and Willapa Bay.

We anticipate few changes in the overall operation of **North Beach Water**. However, you will see a new billing format; automatic payment; a single point of contact; regular newsletters; the development of a website; and system-wide upgrades to include the completion of additional water storage and new piping to physically join the two systems.

These upgrades will improve our fire fighting capability which could reduce the cost of fire insurance; and will allow us to extend water service to currently unserved areas. We will also be evaluating water rates, which have not been reviewed since 1999

We will be holding a public hearing—on Monday March 27<sup>th</sup>, 6:00 PM at the PCFD#1 Meeting Room, in Ocean Park—to discuss the details of our plans and to answer any of your questions. Please join us.

We are proud of our work to retain public control over our water; and we pledge to be the best provider of water services to you, our valued customers and friends.
