This letter is in response to your request for SSC's comments on the map of our certificated territory that you prepared. With one correction noted below, we believe the map is accurate.

At a joint meeting with you and other WUTC staff and including Jim Sands of Blaine Bay Refuse, Inc. on Wednesday, February 26, 2003, you gave us maps showing our respective permit areas in the Blaine and Birch Bay areas.

Your maps of our certificated area was slightly different than I thought our area was, but in that area we currently have no customers because of water and swamp land. We would not expect to have any customers in that area in the future for the same reasons.

Therefore, SSC does not have any problem with our WUTC map of our certificate area as it applies to the Blaine and Birch Bay areas. We also believe the Blaine Bay Refuse; Inc. map that you supplied at that meeting is accurate.

The other area of our map that you gave to us last year related to an area with Nooksack Valley Disposal (NVD). Your map showed the boundary as the Birch Bay Lynden Road into the City of Lynden. I know that both NVD and SSC indicated that the area deviated from the current Birch Bay Lynden Road at the Bay Lyn Road. If you make that adjustment then it would appear that our maps are correct.
