Subject: VERIZON REQUEST FOR A ONE THOUSAND NUMBER BLOCK

Dear Ms. Washburn:

Verizon Northwest Inc. (Verizon) requests the Washington Utilities and Transportation Commission to direct the Pooling Administrator (PA) to provide Verizon with a one thousand number block to satisfy the requirement for additional numbers for Amgen Inc. located in Bothell, WA in the Bothell Rate Center, NPA 425, LATA 674, OCN 4324.

The customer requests a one thousand block of sequential Direct Inward Dialing numbers to accommodate Amgen's growth at this location. Due to the customer's internal numbering plan, the additional numbers must be within the 844 prefix.

This waiver request is made because Verizon's request for a one thousand number block was denied because the serving central office does not meet the "months to exhaust" requirement of the PA. The PA will only accept 6 months or less to exhaust without a waiver request from the Commission. This Rate Center is currently at 18.9 months to exhaust.


The Washington Commission has the authority to review the PA's criteria and request a waiver when appropriate, in this case a waiver request for the months to exhaust criteria. Verizon requests the Commission instruct the PA to release the numbering resources necessary to meet the needs of this Verizon customer.

Verizon requests approval of this request with an effective date of September 14, 2006. The Commission's waiver request must be submitted with the company's application to the PA for the numbering resources needed for deployment of service to this customer.

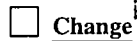

Thousands-Block Application Form Part1A

Instructions for filling out each Section of the Part 1A form:

Section 1.1 Contact information requires that Service Providers supply under "Block Applicant" the company name, company headquarters address, a contact within the company, an address where the contact person may be reached, in addition to the correct phone, fax, and e-mail address. The Pooling Administrator section also requires the Service Provider to fill in the Pooling Administrator's name, address, phone, fax and e-mail.

Section 1.2 Service Providers who need a thousands-block assignment or for an Location Routing Number (LRN) are required to fill in this section. If needed for an LRN, a CO Code Application needs to also be submitted to the PA. The Service Provider should supply the Numbering Plan Area (NPA); the Local Access Transport Area (LATA), which is a three-digit number that can be found in the Telcordia™ LERG™ Routing Guide. The Operating Company Number (OCN) assigned to the service provider and the OCN its parent company. An OCN is a four-character alphanumeric assigned by Telcordia™ Routing Administration (TRA). In addition, the number of thousands-blocks requested should be supplied. The Switch Identification as well as the city or wire center name, rate center, rate center sub zone, homing tandem and CLLI™ tandem of the facilities based provider. Explanations of these terms may be found in the footnotes.

Section 1.3 The date the Service Provider completes the application should be entered in this section, as well as the Effective Date of the requested thousands-block.

Section 1.4 Service Providers should indicate their type, e.g., local exchange carrier, competitive local exchange carrier, interexchange carrier, CMRS.
