Dear Ms. Washburn:

Enclosed you will find the application for Change in Corporate Name and the new tariff. The proposed filing and tariff changes are intended to accomplish the following:

1. Reflect a change in the company's name and
2. To update our tariff to conform to the new rules for investor owned water companies per chapter 480-110 WAC.

Mr. Goodrich operates the corporation Fircroft, Inc. and uses the trade name Fircroft Waterworks. In September, 2004, Mr. Goodrich applied for a tax number for the business. However, Mr. Goodrich forgot that his prior attorney and accountant had already applied for and received a tax number for the business and the s-election was filed. Thus, this caused confusion when he filed for a tax number as sole proprietor and then made an s-election for a business (Fircroft Waterworks) which is not a corporation, but was accepted as an s-corporation. This issue has been resolved with the Internal Revenue Service Center and all business operation related to Mr. Goodrich has been consolidated under the **Fircroft, Inc.** 91-1960646 tax number. There have been no operational changes in regard to Fircroft, Inc and so does not result in any cost to our customers. Upon consulting with Mr. Jim Ward of the Washington Utilities and Transportation Commission, it was decided that the name change is so slight that it will not be necessary to formally inform the customers served by Fircroft, Inc of this name change.

The New WAC provisions and current language and practices have been incorporated by utilizing the generic tariff and updated with no changes to our existing rates.
