Avista Corporation ("the Company") hereby submits the attached filing seeking Commission authorization to increase its rates and charges for its electric and natural gas services to its electric and natural gas customers in the state of Washington. With this filing the Company requests an overall general rate increase of 15.8% or \$51.1 million for electric service and 2.3% or \$4.5 million for natural gas service, to be implemented at the end of the general rate case proceedings.

Additionally, Avista Corporation requests that the Commission immediately suspend the operation of the general tariff revisions included in this filing, and set the matter for hearing including the establishment of a prehearing conference at the earliest possible date in accordance with WAC 480-07-440(1)(a). Also, the Company requests expedited treatment of this filing per Commission guidance issued in Docket No. UE-061411, Final Order No. 4 Paragraph 30.
