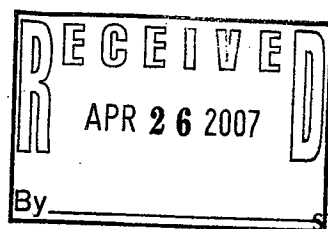

Re: Nonprofit Transportation Certificate

Dear Mr. Simpkin:

The commission has determined that Sunderland Family Treatment Services is not required to obtain a certificate from us to operate as a private nonprofit transportation provider.

In 2006, we surveyed a number of companies and asked three basic questions:

1. Are you registered with the Secretary of State as a nonprofit corporation?
2. Do you transport special needs passengers?
3. Do you receive funding for the express purpose of providing transportation?

To meet the criteria as a private nonprofit transportation provider, you must answer 'yes' to all questions. You answered 'no' to the third question. In March 2007, Bruce Grimm of our staff visited your company to conduct a safety audit and further discuss your response to the survey. Based on the information gathered by Mr. Grimm, we have concluded you do not receive funding for transportation and should not be regulated.
