**Re: REQUEST FOR LESS THAN STATUTORY NOTICE (LSN)
Advice No. 2007-28
Natural Gas Tariff Filing – Filed Electronically**

Dear Ms. Washburn:

Pursuant to RCW 80.28.060 and WAC 480-80-101 and WAC 480-80-105(1)(c), please find enclosed for filing the following proposed revision to the WN U-2 Tariff for natural gas service of Puget Sound Energy (the "Company"):

11th Revision of Sheet No. 101-B – Schedule No. 1, Tax Adjustment (Continued)

The purpose of this filing is to incorporate the effect of a change to the municipal tax within the City of Rainier (the "City"). A copy of the approved City ordinance, Ordinance No. 525 is enclosed.

The rate change imposed by the enclosed ordinance is an increase to 6% from the current 4%. With the proposed electric tax increase coincident with this filing, the Company estimates the resulting annualized increase in gross revenues from electric and natural gas utility operations within the City to be \$20,183.

The Company respectfully requests that the Commission allow these tariff changes to become effective on November 8, 2007, with less than statutory notice (LSN), in order to allow the Company to adjust rates due to this city tax which became effective January 1, 2006. The information required by WAC 480-80-122 is contained throughout this letter and on the attached LSN form provided by the Commission. Tom DeBoer is authorized to issue tariff changes on behalf of the Company.

The enclosed tariff sheet reflects a date of November 8, 2007 in the column titled "Rate's Effective Date." Should the Commission reject the Company's request for LSN treatment, the Company is willing to submit a substitute sheet adjusting this date to November 30, 2007.

The tariff sheet described herein reflects an issue date of October 30, 2007, and an effective date of November 30, 2007. Notice of proposed tariff changes, as required by law and the Commission's rules and regulations, is being given to the public immediately prior to or coincident with the date of this transmittal letter through web, telephone and mail access in accordance with WAC 480-90-193.

Pursuant to WAC 480-90-195 and 480-90-198, in the first billing after the tariff revision becomes effective, the electric customers within the City will receive additional notification in the form of a bill message.
