(a) Proposed changes: Install WSDOT provided HXP-1 constant warning device. Replace system batteries and charger. Replace 8 inch lights with 12 inch LED type. Install power off indicator light.

- (b) Justification for changes: Current train detection system obsolete, parts no longer available. System batteries and charger have outlived life expectancy. 8 inch lights are obsolete, 12 inch LED are industry standard. Power off light indicates if commercial power is interrupted.
- (c) Affects of proposed changes on warning devices and warning times for drivers: Designed warning time of approximately 30 seconds will not change. Warning times will be consistent with varying train speeds. 12 inch LED lights will provide greater visibility for motorist.
