(a) Proposed changes: Install WSDOT provided bungalow complete with style C train detection. Replace 8 inch lights with WSDOT provided shoulder mounted 12 inch lights including foundations. Replace all underground cable runs for light and track circuits.

(b) Justification for changes: Current train detection system obsolete. Replacement bungalow equipped with industry standard train detection equipment. 8 inch lights obsolete, 12 inch are industry standard. Current underground signal and track circuit cable have open or failed conductors.

(c) Affects of proposed changes on warning devices and warning times for drivers: 12 inch flashing light heads will enhance visibility for motorist. No change in warning times.
