The City of Spokane would like to continue the Pre-Rule Quiet Zones that qualify for automatic approval for the Union Pacific Railroad. The regulatory provision that provides the basis for the continuation of this quiet zone is "222.41 (a) Pre-Rule Quiet Zones that qualify for automatic approval."
