Tariff No. 9 - New Toters and Containers Added

Yakima Waste Systems, Inc. is filing revised tariff pages for rates and new services being offered to regulated customers. The new services are 48, 64 or 96 gallon toters for residential garbage customers who request the toter and recycling and yard waste customers, existing and new. A new eight (8) yard container and 48, 64 or 96 gallon toter service is being offered to commercial garbage customers who request the service.

The new services and revised tariff pages are as follows:

1. Tariff No. 9, 13th Revised Page 2 - Check Sheet.
2. Tariff No. 9, 1st Revised Page 17 - Item 52-Re-delivery Fees-adding a re-delivery fee for the 48, 64 or 96 gallon toter customers whose residential service has been terminated for delinquent accounts.
3. Tariff No. 9, 1st Revised Page 19 - Item 70-Return Trips - adding a return trip charge for 48, 64 or 96 gallon toters.
4. Tariff No. 9, 1st Revised Page 23 - Item 100 - Residential Service - adding new service for residential customers requesting 48, 64 or 96 gallon toter service for garbage service.
5. Tariff No. 9, 1st Revised Page 24 - Item 100 - Residential Service (continued) - adding roll out charges for movement of the cart more than 25 feet and adding charges for occasional extras for customers using 48, 64 or 96 gallon toter service.
6. Tariff No. 9, 1st Revised Page 25 - Item 100 - Residential Service (continued) - revision of the residential curbside recycling program moving from the three bin system to a "single stream" collection system using 64 gallon toters. The hauler will accept additional types of plastic bottles and jars #1-7 and including any bottle with a neck narrower than its base.

Yakima County Solid Waste Advisory Committee has moved clear glass from a Tier 1 to a Tier 2 level and removed glass from the required materials for the curbside recycling program in Yakima County. That action was taken at SWAC's meeting on March 13, 2008. Resolutions from that meeting will be forwarded to the WUTC as soon as they are available.

7. Tariff No. 9, 1st Revised Page 27 - Item 105 - Multi-family Service - adding new service for the 48, 64 and 96 gallon toters in Multi-family garbage service.
8. Tariff No. 9, 1st Revised Page 32 - Item 207 - Excess Weight - adding new charges for overfilled or overweight 48, 64, or 96 gallon toters.
9. Tariff No. 9, 1st Revised Page 35 - Item 240 - Container Service - The company is adding a new eight (8) container size for permanent commercial customers.
10. Tariff No. 9, Original Page 35A - Item 240 - Container Service - The company is also offering the 49, 64 or 96 gallon toters to commercial customers.

The rates calculated for the 48, 64 and 96 gallon toters used for garbage service are determined using an equivalent gallon cost as compared to the 1, 2 or 3 can rate, plus a small fee for cost recovery of the investment in toters and trucks. The 8 yard container rate is also calculated on an equivalent yardage rate as compared to other container sizes. The revenue effect of the new services has not been determined.

An LSN Form is enclosed with this transmittal letter and revised tariff pages requesting this filing be approved for an effective date of April 1, 2008. The new tariff pages and new services added on existing tariff pages are being filed under the provisions of WAC 480-70-262 (2).
