Dear Secretary Washburn:

Our company, Sanitary Disposal, Inc. (G000173), operates as a solid waste company in Oregon and Washington, and as such, is required to file an annual report to your Commission on our Washington operations.

Once again, we are requesting to file a Class "C" report rather than the Class "A&B", which has been requested by the Commission. We filed and paid Class "C" reports on a timely basis for a number of years. In 2005, we requested and you granted us the option of filing a Class "C" report rather than the "A&B".

Filing this report causes a financial cost to our company that is disproportionate to the amount of income earned from our Washington operations. Our gross income derived from Washington sources is \$218,679.00 which represents approximately 4.95% of our total income. Our company is locally owned and operated and does not include adequate accounting personnel to prepare the Commission report; therefore, we are forced to have our CPA firm prepare them for us, creating additional costs.

We appreciate your consideration in this matter, both past and present. We request that you review our request for filing a Class "C" report for 2007 and future years, in lieu of the Class "A&B", as requested by the commission. Should our circumstances change dramatically in the future, we will of course, inform you.

Dear Mr. Jewett:

The Washington Utilities and Transportation Commission received your letter of March 15, 2005, requesting to file a Class C Annual Report rather than a Class A & B Annual Report (TG-050450).

Sanitary Disposal, Inc., states in its letter that regulated Washington operations generate revenues of approximately \$147,174 (approximately 3.6% of total income) for providing traditional solid waste collection service to 170 residential and 8 drop-box customers in Washington.

Commission Staff reviewed the request and supports Sanitary Disposal, Inc.'s request to file a Class C Annual Report for the 2004 period. The Class C Annual report contains sufficient detail to adequately exercise regulatory overview of Sanitary Disposal, Inc., whose regulated revenue and customer counts are so low. For this reason, this request is consistent with the public interest and approved.
