RE: Intent to Exercise Jurisdiction over Solid Waste Collection

To Whom It May Concern:

The City of Walla Walla, a code city, has determined that it wishes to provide solid waste collection services itself pursuant to RCW 81.77.020. This letter is to notify the Washington Utilities and Transportation Commission of the city's decision, pursuant to RCW 35A.14.900 to exercise jurisdiction over the collection of solid waste within the city limits.

This action was authorized by Ordinance Nos. 2007-47 and 2008-26, copies of which are enclosed. The effective date of the city's operation under these ordinances is as follows:

- Effective date of Ordinance No. 2007-47 is December 31, 2007.
- Effective date of Ordinance No. 2008-26 is December 31, 2008.

The city recognizes the provisions of the statute require that the city work with the holder of any franchise or permit that is canceled by the city's decision. In the event the city reverses its decision at any time in the future, we will notify the Commission so that the Commission can carry out its responsibilities under the law.

ORDINANCE NO. 2007-47

AN ORDINANCE ANNEXING UNINCORPORATED LAND WITHIN THE CITY OF WALLA WALLA'S URBAN GROWTH AREA BOUNDARY, CONSISTING OF APPROXIMATELY 355.62 ACRES OF TERRITORY COMMONLY REFERRED TO AS THE PENNBROOK HOMES PROPERTY, CANCELING AND GRANTING FRANCHISES IN THE ANNEXED TERRITORY, AND TAKING SUCH OTHER ACTION RELATED THERETO

WHEREAS, the City of Walla Walla passed Municipal Ordinance A-2405 on May 13, 1970 which classified the City of Walla Walla as a nonchartered code city under Title 35A of the Revised Code Washington (RCW); and

WHEREAS, the City of Walla Walla annexed property to its city limits by Municipal Ordinance A-3267 passed on April 27, 1983; and

WHEREAS, the Walla Walla County Board of Commissioners passed County Resolution number 90-449 on October 30, 1990 opting into planning activities under the Washington Growth Management Act, RCW Ch. 36.70A; and

WHEREAS, RCW Ch. 35A.14 provides for annexation by direct petition initiated by the filing of notification by owners of property in the territory proposed for annexation which is not less than ten percent (10%) of the assessed value of the property to be annexed; and

WHEREAS, the City of Walla Walla has received sufficient notification from property owners of intent to annex territory consisting of approximately 355.62 acres of property, being generally located adjacent to and southeasterly of U.S. 12 and contiguous to the city limits established by Municipal Ordinance A-3267; and

WHEREAS, the Board of Commissioners for Walla Walla County passed Walla Walla County Ordinance 322 on October 31, 2005 including the area proposed for annexation within the City of Walla Walla's urban growth area; and

WHEREAS, the Walla Walla City Council passed Municipal Resolution 2007-67 at its August 8, 2007 regular meeting setting August 22, 2007 as the date for meeting to determine whether the city would accept, reject, or geographically modify the proposed annexation; and

WHEREAS, the Walla Walla City Council considered this matter at its August 22, 2007 regular meeting and passed Municipal Resolution 2007-74 determining certain matters with respect to the proposed annexation; and

WHEREAS, the owners of property in the area which is not less than sixty percent (60%) of the assessed value of the property to be annexed have signed a petition for annexation; and

WHEREAS, notice was given to the Walla Walla County Boundary Review Board on September 19, 2007 of the initiators' intention to annex the area proposed for annexation; and

WHEREAS, forty-five days has elapsed since the date of notice of intent to annex without the board's jurisdiction having been invoked and the proposed action is therefore deemed approved pursuant to RCW 36.93.100; and

WHEREAS, the Walla Walla City Council passed Municipal Resolution 2007-88 at its November 14, 2007 regular meeting setting a public hearing for November 28, 2007 upon such proposed annexation; and

WHEREAS, the Walla Walla City Council conducted a public hearing at its November 28, 2007 regular meeting; and

WHEREAS, this ordinance was introduced for first reading at the December 5, 2007 Walla Walla City Council meeting following the public hearing; and

WHEREAS, this ordinance was introduced for second reading at the December 19, 2007 Walla Walla City Council meeting and was passed; and

WHEREAS, the Walla Walla City Council has considered this matter during a regularly and duly called public meeting of said Council, has given said matter careful review and consideration, and finds that good government and the best interests of the City of Walla Walla will be served by annexation of the area described in section 1 hereto and taking such other action related thereto;

**NOW THEREFORE, the City Council of the City of Walla Walla do ordain as follows:**

**Section 1:** Approximately 355.62 acres of property, being generally located adjacent to and southeasterly of U.S. 12 and contiguous to the City of Walla Walla, and legally described below, is hereby annexed to the City of Walla Walla effective December 31, 2007:

A parcel of land in the South One-half of Section 12 and the Northeast and Northwest One-quarters of Section 13, Township 7 North, Range 36 East of the Willamette Meridian, Walla Walla County, Washington, more particularly described as follows:

Beginning at the Northeast corner of said Section 13 thence South 01°31'42" East along the east line of said Section, a distance of 1,747.51 feet to a point on the north line of a parcel of land belonging to Pat McConnell; thence along said north line the following nine courses:

1. South 69°48'59" West, a distance of 194.15 feet;
2. South 74°31'59" West, a distance of 348.50 feet;
3. South 83°46'59" West, a distance of 111.40 feet;
4. North 76°36'01" West, a distance of 166.00 feet;
5. South 69°40'59" West, a distance of 180.00 feet;
6. South 89°40'59" West, a distance of 114.00 feet;
7. North 69°19'01" West, a distance of 149.00 feet;
8. North 14°04'01" West, a distance of 187.15 feet;

- 9 North 85°26'56" West, a distance of 1,416.86 feet to a point on the east line of a parcel of land belonging to the City of Walla Walla;

Thence along the west and north lines of said City parcel the following two courses;

1. North 01°54'47" West, a distance of 191.21 feet;
2. South 88°07'11" West, a distance of 1,282.24 feet to the point on the easterly right of way of State Route Number 12, said point being a point of curve of a non tangent curve to the left, of which the radius point lies North 61°44'08" West, a radial distance of 1,475.00 feet;

Thence northerly along the arc of said curve and along the said Highway right of way through a central angle of 12°22'43", a distance of 318.67 feet; Thence continuing along said right of way the following sixteen courses;

1. North 16°43'17" East, a distance of 342.87 feet;
2. North 74°07'01" West, a distance of 114.00 feet;
3. North 15°53'08" East, a distance of 2,298.70 feet to a point of spiral curvature;
4. Thence northeasterly 200.00 feet along the arc of said spiral curve, whose long chord bears North 16°52'44" East a distance of 197.36 feet to a point of curve to the right having a radius of 1,860.00 feet and a central angle of 43°34'15";
5. Thence northeasterly along the arc of said curve, a distance of 1,414.45 feet to a point of spiral curvature;
6. Thence northeasterly 200.00 feet along the arc of said spiral curve, whose long chord bears North 64°27'56" East a distance of 197.36 feet to a point of tangency;
7. North 65°27'22" East, a distance of 252.07 feet;
8. North 24°32'38" West, a distance of 10.00 feet;
9. North 65°27'22" East, a distance of 1,163.40 feet;

10. North 68°19'07" East, a distance of 100.12 feet;
11. North 65°27'22" East, a distance of 100.00 feet;
12. North 66°53'17" East, a distance of 200.06 feet;

14. South 60°07'11" East, a distance of 102.29 feet;
15. South 01°24'31" East, a distance of 42.34 feet;
16. North 88°35'29" East, a distance of 30.00 feet to a point on the east

line of said Section 12;

Thence South 01°24'31" East along said east line a distance of 3,484.10 feet to the POINT OF BEGINNING.

Containing 355.62 acres, more or less.

All situated in Walla Walla County, State of Washington.

**Section 2:** The Walla Walla Zoning Code, Walla Walla Municipal Code Title 20, as amended, Walla Walla Municipal Ordinance 2007-26, as amended, and the zoning designation of Urban Planned Community (UPC), are hereby adopted as zoning regulations for the property described in section 1 herein upon the effective date of annexation. The City of Walla Walla hereby accepts and assumes the development agreement approved by Walla Walla County Resolution 06-324 on November 13, 2006.

**Section 3:** Subject to any applicable exemptions, all property within the area described in section 1 herein shall be assessed and taxed at the same rate and on the same basis as other property in the City of Walla Walla is assessed and taxed subject to any applicable exemptions. Subject to any applicable exemptions, all property within the area described in section 1 herein shall be assessed and taxed at such rate and basis to pay for any outstanding indebtedness of the City of Walla Walla contracted prior to, or existing at, the date of annexation.

**Section 4:** The annexation of the territory described in section 1 herein shall cancel, as of the effective date of such annexation, any franchise or permit theretofore granted to any person, firm or corporation by the state of Washington, or by the governing body of such territory, authorizing or otherwise permitting the operation of any public utility, including but not limited to, public electric, water, transportation, garbage disposal, solid waste collection, or other similar public service business or facility within the limits of the annexed territory.

A. The holder of any such franchise or permit canceled pursuant to this section is forthwith granted by the City of Walla Walla a franchise to continue such business within the annexed territory for a term which shall expire upon the earliest of either (a) the purchase by the City of Walla Walla of said franchise, business, or facilities at an agreed or negotiated price, (b) the expiration of the remaining term of the original franchise or permit, or (c) the expiration of one hundred thirty-eight (138) months following the effective date of annexation. This franchise shall be exclusive except nothing herein shall prevent the City of Walla Walla from extending similar or competing services to the annexed territory by franchise, permit or public operation upon a proper showing of the inability or refusal of the

franchisee to adequately service said annexed territory at a reasonable price.

B. The City of Walla Walla hereby decides to contract for solid waste collection or provide solid waste collection itself pursuant to RCW 81.77.020 as of the effective date of annexation. The Walla Walla City Clerk is hereby directed to notify the State of Washington Utilities and Transportation Commission, in writing, of the City of Walla Walla's decision to contract for solid waste collection or provide solid waste collection itself pursuant to RCW 81.77.020 as of the effective date of annexation and to attach a copy of this ordinance to such notification.

C. Terms and conditions of solid waste collection franchises. The following terms and conditions apply to solid waste collection franchises:

(1) Franchisees must notify the City of Walla Walla in writing of any change in physical business address, business mailing address, or business telephone number. The notice must be filed at least ten days before the effective date of the change.

(2) Franchisees must keep and maintain records as provided in Washington Administrative Code Section (WAC) 480-70-061. Franchisees must adhere to accounting requirements of WAC 480-70-066. Franchisees must file with the City of Walla Walla, by no later than May 1 of each year, a complete, accurate, annual report showing an end-of-the-year summary of financial and operational activity of franchisee in the annexed territory. Each franchisee shall make its records available for inspection by the City of Walla Walla.

(3) Franchisees shall maintain insurance in a form and amount as provided in WAC 480-70-181 which covers each motor vehicle it operates in the annexed territory.

(4) Franchisees shall comply with WAC 480-70-191, 480-70-196, WAC 480-70-201, WAC 480-70-206, and WAC 480-211 with respect to their equipment and drivers.

(5) Franchisees shall comply with biomedical waste and hazardous waste rules and regulations promulgated by the State of Washington Utilities and Transportation Commission.

(6) Customers in the annexed territory shall be subject to the same rates, charges, customer notice requirements, and consumer rules which apply to the franchisee's customers in unincorporated areas of Walla Walla County.

(7) Franchisees shall pay a franchise fee to the City of Walla Walla at a rate of one percent of the franchisee's annual gross operating revenue for the annexed territory. Franchise fees must be paid to the City of Walla Walla by April 1 of each year. The franchise fees shall be used to cover the costs of regulating franchisee.

(8) Franchisees shall comply with all federal, state, and local rules and regulations. The terms and conditions of this franchise do not relieve any franchisee from any of its duties or obligations under the laws of the United States, the State of Washington,

Walla Walla County, or the City of Walla Walla. The City of Walla Walla reserves and retains the authority to impose additional or different requirements on any solid waste collection company in appropriate circumstances, consistent with the requirements of law.

(9) WAC 480-70-041 is hereby incorporated for the definition of terms used in the Washington Administrative Code, and the City of Walla Walla adopts by reference the regulations and standards identified in WAC 480-70-999.

(10) Any amendment of the rules and regulations referenced in this franchise grant shall be deemed to amend the terms hereof in conformity therewith.

(11) Noncompliance with any of the terms or conditions of this franchise shall be deemed to be an inability or refusal of the franchisee to adequately service the annexed territory at a reasonable price.

**Section 5:** The Walla Walla City Clerk is directed to file a certified copy of this ordinance with the Board of Commissioners for Walla Walla County as provided in RCW 35A.14.140.

**Section 6:** The Walla Walla City Clerk is directed to submit certificates of annexation as provided in RCW 35A.14.700.


**Section 7:** The Walla Walla City Clerk is directed to file, record, and give notice of this ordinance in such manner as required by law.

**Section 8:** The Walla Walla City Clerk is directed to publish a summary of this ordinance as permitted by RCW 35A.13.200 and 35A.12.160 in the form attached hereto.



ORDINANCE NO. 2008-26

AN ORDINANCE ANNEXING APPROXIMATELY 2.89 ACRES OF PROPERTY, BEING GENERALLY LOCATED ON THE SOUTH SIDE OF ABBOTT RD. NEAR MURR FIELD, CANCELING AND GRANTING FRANCHISES IN THE ANNEXED TERRITORY, AND TAKING SUCH OTHER ACTION RELATED THERETO

WHEREAS, the City of Walla Walla passed Municipal Ordinance A-2405 on May 13, 1970 which classified the City of Walla Walla as a nonchartered code city under Title 35A of the Revised Code Washington (RCW); and

WHEREAS, the Walla Walla County Board of Commissioners passed County Resolution number 90-449 on October 30, 1990 opting into planning activities under the Washington Growth Management Act, RCW Ch. 36.70A; and

WHEREAS, RCW Ch. 35A.14 provides for annexation by direct petition initiated by the filing of notification by owners of property in the territory proposed for annexation which is not less than ten percent (10%) of the assessed value of the property to be annexed; and

WHEREAS, the City of Walla Walla has received sufficient notification from property owners of intent to annex territory consisting of approximately 2.89 acres of property, being generally located on the south side of Abbott Rd. near Murr Field; and

WHEREAS, the Walla Walla City Council passed Municipal Resolution 2008-53 at its May 28, 2008 regular meeting setting June 25, 2008 as the date for meeting to determine whether the city would accept, reject, or geographically modify the proposed annexation; and

WHEREAS, the Walla Walla City Council considered this matter at its June 25, 2008 regular meeting and passed Municipal Resolution 2008-67 determining certain matters with respect to the proposed annexation; and

WHEREAS, the owners of property in the area which is not less than sixty percent (60%) of the assessed value of the property to be annexed have signed a petition for annexation; and

WHEREAS, notice was given to the Walla Walla County Boundary Review Board on August 13, 2008 of the initiators' intention to annex the area proposed for annexation; and

WHEREAS, forty-five days has elapsed since the date of notice of intent to annex without the board's jurisdiction having been invoked and the proposed action is therefore deemed approved pursuant to RCW 36.93.100; and

WHEREAS, the Walla Walla City Council passed Municipal Resolution 2008-87 at its October 8, 2008 regular meeting setting a public hearing for November 5, 2008 upon such proposed annexation; and

WHEREAS, the Walla Walla City Council conducted a public hearing at its November 5, 2008 regular meeting; and

WHEREAS, this ordinance was introduced for first reading at the November 5, 2008 Walla Walla City Council meeting following the public hearing; and

WHEREAS, this ordinance was introduced for second reading at the November 19, 2008 Walla Walla City Council meeting and was passed; and

WHEREAS, the Walla Walla City Council has considered this matter during a regularly and duly called public meeting of said Council, has given said matter careful review and consideration, and finds that good government and the best interests of the City of Walla Walla will be served by annexation of the area described in section 1 hereto and taking such other action related thereto;

**NOW THEREFORE, the City Council of the City of Walla Walla do ordain as follows:**

**Section 1:** The following described property is hereby annexed to the City of Walla Walla effective December 31, 2008:

Tract 35 of Abbott Acre Tract Addition to the Walla Walla City, according to the official plat thereof recorded in Volume D of Plats at Page 21, records of Walla Walla County.

Excepting therefrom the West 82.865 feet in width of said Tract 35.

All situated in Walla Walla County, State of Washington.

**Section 2:** The Walla Walla Zoning Code, Walla Walla Municipal Code Title 20, as amended, and the zoning designation of R-96 Low Density Single-Family Residential are hereby adopted as zoning regulations for the property described in section 1 herein upon the effective date of annexation.

**Section 3:** Subject to any applicable exemptions, all property within the area described in section 1 herein shall be assessed and taxed at the same rate and on the same basis as other property in the City of Walla Walla is assessed and taxed subject to any applicable exemptions. Subject to any applicable exemptions, all property within the area described in section 1 herein shall be assessed and taxed at such rate and basis to pay for any outstanding indebtedness of the City of Walla Walla contracted prior to, or existing at, the date of annexation.

**Section 4:** The annexation of the territory described in section 1 herein shall cancel, as of the effective date of such annexation, any franchise or permit theretofore granted to any person, firm or corporation by the state of Washington, or by the governing body of such territory, authorizing or otherwise permitting the operation of any public utility, including but not limited to, public electric, water, transportation, garbage disposal, solid waste

collection, or other similar public service business or facility within the limits of the annexed territory.

A. The holder of any such franchise or permit canceled pursuant to this section is forthwith granted by the City of Walla Walla a franchise to continue such business within the annexed territory for a term which shall expire upon the earliest of either (a) the purchase by the City of Walla Walla of said franchise, business, or facilities at an agreed or negotiated price, (b) the expiration of the remaining term of the original franchise or permit, or (c) the expiration of one hundred thirty-eight (138) months following the effective date of annexation. This franchise shall be exclusive except nothing herein shall prevent the City of Walla Walla from extending similar or competing services to the annexed territory by franchise, permit or public operation upon a proper showing of the inability or refusal of the franchisee to adequately service said annexed territory at a reasonable price.

B. The City of Walla Walla hereby decides to contract for solid waste collection or provide solid waste collection itself pursuant to RCW 81.77.020 as of the effective date of annexation. The Walla Walla City Clerk is hereby directed to notify the State of Washington Utilities and Transportation Commission, in writing, of the City of Walla Walla's decision to contract for solid waste collection or provide solid waste collection itself pursuant to RCW 81.77.020 as of the effective date of annexation and to attach a copy of this ordinance to such notification.

C. Terms and conditions of solid waste collection franchises. The following terms and conditions apply to solid waste collection franchises:

(1) Franchisees must notify the City of Walla Walla in writing of any change in physical business address, business mailing address, or business telephone number. The notice must be filed at least ten days before the effective date of the change.

(2) Franchisees must keep and maintain records as provided in Washington Administrative Code Section (WAC) 480-70-061. Franchisees must adhere to accounting requirements of WAC 480-70-066. Franchisees must file with the City of Walla Walla, by no later than May 1 of each year, a complete, accurate, annual report showing an end-of-the-year summary of financial and operational activity of franchisee in the annexed territory. Each franchisee shall make its records available for inspection by the City of Walla Walla.

(3) Franchisees shall maintain insurance in a form and amount as provided in WAC 480-70-181 which covers each motor vehicle it operates in the annexed territory.

(4) Franchisees shall comply with WAC 480-70-191, 480-70-196, WAC 480-70-201, WAC 480-70-206, and WAC 480-211 with respect to their equipment and drivers.

(5) Franchisees shall comply with biomedical waste and hazardous waste rules and regulations promulgated by the State of Washington Utilities and Transportation Commission.

(6) Customers in the annexed territory shall be subject to the same rates, charges, customer notice requirements, and consumer rules which apply to the franchisee's customers in unincorporated areas of Walla Walla County.

(7) Franchisees shall pay a franchise fee to the City of Walla Walla at a rate of one percent of the franchisee's annual gross operating revenue for the annexed territory. Franchise fees must be paid to the City of Walla Walla by April 1 of each year. The franchise fees shall be used to cover the costs of regulating franchisee.

(8) Franchisees shall comply with all federal, state, and local rules and regulations. The terms and conditions of this franchise do not relieve any franchisee from any of its duties or obligations under the laws of the United States, the State of Washington, Walla Walla County, or the City of Walla Walla. The City of Walla Walla reserves and retains the authority to impose additional or different requirements on any solid waste collection company in appropriate circumstances, consistent with the requirements of law.

(9) WAC 480-70-041 is hereby incorporated for the definition of terms used in the Washington Administrative Code, and the City of Walla Walla adopts by reference the regulations and standards identified in WAC 480-70-999.

(10) Any amendment of the rules and regulations referenced in this franchise grant shall be deemed to amend the terms hereof in conformity therewith.

(11) Noncompliance with any of the terms or conditions of this franchise shall be deemed to be an inability or refusal of the franchisee to adequately service the annexed territory at a reasonable price.

**Section 5:** The Walla Walla City Clerk is directed to file a certified copy of this ordinance with the Board of Commissioners for Walla Walla County as provided in RCW 35A.14.140.

**Section 6:** The Walla Walla City Clerk is directed to submit certificates of annexation as provided in RCW 35A.14.700.

**Section 7:** The Walla Walla City Clerk is directed to file, record, and give notice of this ordinance in such manner as required by law.

**Section 8:** The Walla Walla City Clerk is directed to publish a summary of this ordinance as permitted by RCW 35A.13.200 and 35A.12.160 in the form attached hereto.

**Section 9:** If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance and the application of the provision to other persons or circumstances is not affected.




