Tariff Revisions Re: Large Commercial / Industrial Provisions

Dear Mr. Danner:

Northwest Natural Gas Company, dba NW Natural (NW Natural or Company), files herewith revisions to its Tariff, P.U.C. Or. 24, as listed on the attached Table of Tariff Sheet revisions. The Tariff sheets are stated to become effective with service on and after **July 31, 2009**:

The purpose of this filing is to revise portions of the Company's Tariff to clarify existing provisions that the Company has learned through experiences during the 2008-2009 heating season were either unclear or incomplete. Prior to submission of this filing, the Company reviewed the revisions proposed herein with a representative of the Northwest Industrial Gas Users (NWIGU).

This filing also proposes the elimination of Rate Schedule 54 "Emergency Sales Service". The Company has sole discretion to make gas available to non-residential customers for emergency purposes under Schedule 54. The Company has not authorized gas usage under this Rate Schedule since the early 1990's, when its availability was restricted to institutional customers, defined as "public and private schools; hospitals and other medical care facilities; churches; and facilities of municipal state and federal governments and agencies thereof, except those leased or rented for non-government purposes".

There is no clear role for Schedule 54 emergency service in today's operating environment. However, in discussions with a representative from NWIGU, the Company agreed that service to certain institutional customers should carry a higher priority than other non-residential customers. These higher priority customers are better identified as essential human needs customers where such customers use natural gas

to operate equipment that is necessary to support or sustain human life. As such, we have refined the definition of an essential human needs customer, and we have added language to General Rule 15 "Curtailment Priority" that adds additional protection to a firm service essential human needs customer in the event of firm service curtailment. An essential human needs customer that chooses to take service under an interruptible service option will be subject to curtailment in the same manner as any other non-residential customer. However, language has been added to General Rule 16 that provides additional protection to the essential human needs customer from being valved-off for failure to comply with a curtailment order.
