Dear Mr. Danner:

I am requesting a formal opinion by the Washington State Utilities and Transportation Commission on the enclosed application I have received for boat transportation on Lake Chelan.

Several phone conversations and e-mails have occurred between my staff, Margi Gromek, the proponent, Stehekin Boat Service, and your staff, Penny Ingram. The special use permit issued by the National Forest will authorize the use of National Forest facilities by Stehekin Boat Service for the purpose of operating a charter service between Stehekin and Field's Point Landing and other dock locations on the National Forest.

I am enclosing the correspondence on this topic with both the proponent and my staff and Penny Ingram. Starting in September of 2007 where I asked Mr. Jim Courtney to check with the State of Washington WUTC to determine if a permit was needed from the State. In October of 2007 I received a letter from Mr. Courtney with an e-mail from Ms Ingram indicating that the proposed service would be exempt from commercial ferry operation. Feedback from the Lake Chelan Boat Company that I received prompted me to have a phone conversation on March 18, 2008 with Ms. Ingram and Jack and Cindy Raines about the staff findings that the operations would be exempt. On March 19, 2008 I requested from Penny Ingram a review of the proposal received from Mr. Courtney (Owner of Stehekin Boat Service). You will see that on March 31, 2008 we received an e-mail informing us that the **staff changed its opinion** and determined that Mr. Courtney would need a Certificate of Public Convenience and Necessity to operate his vessel on Lake Chelan. I signed a letter on May 5, 2008 addressed to Mr. Courtney indicating that he would need to obtain this Certificate and then I could proceed with our permit process. Our permit requires operators to comply with all federal, state and local regulations. Then on July 18, 2008 we were sent an e-mail from Ms Ingram that was based on further correspondence with Mr. Courtney indicating that your staff had now determined that the WUTC would not have any regulatory authority over a charter service and therefore he would not need the Certificate of Public Convenience.

During this time and in each correspondence it is clear that Ms. Ingram is presenting an informal opinion and is not binding on the commission if a formal determination is requested. In order to make sure that I am not issuing a permit in violation of State of Washington's Regulations, I am asking for that formal determination. Since the current passenger ferry operation, The Lake Chelan Boat Company, is concerned over a second ferry service on the Lake, I would like to have a determination prior to issuing a permit for use of National Forest facilities.





Along with the correspondence I am also enclosing the operating plan that was submitted to us by Stehekin Boat Service which includes services offered, equipment to be used, safety plan and client charges. Does the plan of operation in this application meet the WAC 480-51-020 code that defines a charter service?

Please let me know if you need additional information.

The docks we would like to use are already public and commerical facilities and in some cases the only dock at the location.

Attachment for #7 of Application and Utility Systems and Facilities on Federal Lands

Stehekin Boat Service will be a Charter Boat operation on Lake Chelan based at the northwest end of the Lake in Stehekin. This proposal would mainly operate between Stehekin and Field Point. However, it would also land at Lucerne, Prince Creek, Chelan and other private docks as well as campgrounds and trail heads on Lake Chelan.

This operation will be an "On Demand Charter Boat" hauling passengers up and down Lake Chelan and will be operating year around. The docking times and numbers of dockings will vary depending on passenger demand, however, we will beware of the other Boat operations and will work in a way to not be in conflict with their schedules and docking times.

APPENDIX B

Annual Operating Plan

Owner and Manager:

Stehekin Boat Service is owned and operated by Jim and Rene Courtney of PO Box 296, Stehekin, WA 98852. Our telephone number is 509-470-1799.

Type of Permit:

Two Year Permit

Seasons of Use:

Year-round transport will be provided on-call for clients to National Forest docks.

Outfitter Equipment:

40' Passenger Boat is Gray with "Liberty" printed on the side of the boat. Its WN number is: 9793NS. It has a Vessel Registration number of: WNZ9653CA363.

Names of Guides and Experience:

Jim Courtney – 36 years experience operating boats and barges on Lake Chelan.

Services Offered to Clients/Areas of Approved Use:

Stehekin Boat Service will operate on-call year round to transport clients to Forest Service docks along Lake Chelan. The business is based in Stehekin on private land. Field's Point will be the main dock utilized, but stops at all other docks along the lake would also be provided, and serve clients primarily from Stehekin and Chelan. Up to a maximum of 480 client service days (one way trips) to National Forest docks may be made per year. Boat tours would not be offered, only transportation between docks.

Client Camping Practices Information:

We provide transportation only and not guided camping. However, as part of our permit agreement, we will provide our camping clients with written information and have them sign off on an agreement to abide by the "leave no trace", "pack it in – pack it out" and "minimum impact" guidelines. As part of these guidelines we will provide information that advises customers they are prohibited from cutting snags.

Clients will be advised that they should cook with stoves to minimize impact on the area. Where fires are allowed they must take all appropriate safety measures and use only existing and continually renewed down woody material for firewood. They will also be advised that they are prohibited from collecting or damaging historic or prehistoric artifacts or sites, and that to do so is a violation of Federal law. Also, they are obligated to report the location of any sites discovered to the Forest Service.

We will provide transportation for our customer's garbage for proper disposal. We will also provide customers with information regarding proper camp sanitation so they do not provide an attractive nuisance to wildlife. Camping clients will be informed that toilet areas are to be a minimum of 200 feet from all water sources. Additionally, we will monitor the current and expected wildfire conditions and keep our customers apprised of any current or expected restrictions on fires.

We will not provide transportation for mechanized equipment (e.g. chainsaw) to drop off points near designated wilderness areas unless pre-approved in writing by a Forest Service Officer. We will limit our group sizes to 12 individuals if we are landing them near designated wilderness areas. We will provide a report to the Forest Service that will include: use dates, landing locations, party sizes. We will evaluate effects on these locations at permit renewal.

If dens or nest sites are located for species protected under the Endangered Species Act those sites will be excluded as possible landing or camping sites during the reproductive season.

The approved dock transport areas are displayed in Appendix A: "Map of Stehekin Boat Service's Dock Locations".

Safety Plan:

We have a Coast Guard and Washington State Labor & Industries Marine Division approved boat and equipment. Our boat operators will be first aid and CPR qualified. Additionally, we will carry a VHF radio and cell phone to facilitate contact in the event of an emergency. Our boats carry fire extinguishers, first aid kits, lifejackets and a whistle. We will follow all standard safety practices.

Stehekin Boat Service will not use Field's Point or any other docks during the Lake Chelan Boat Company's scheduled times or actual use at any location.

Client Charges:

Our standard rate will start at \$35 one way between the points of Stehekin and Field's Point, with a reduced rate for families with children under 12, and free for ages 6 and under. Fees for other stops have not been determined. A minimum fee would apply per trip if a small number of clients travel.


Exempt vessels and operations.

The rules of this chapter do not apply to the following vessels or operations:

- (1) Charter services;
- (2) Passenger-carrying vessels that depart and return to the point of origin without stopping at another location within the state where passengers leave the vessel;
- (3) Vessels operated by not-for-profit or governmental entities that are replicas of historical vessels or that are recognized by the United States Department of the Interior as national historical landmarks;
 - (4) Excursion services that:
- (a) Originate and primarily operate at least six months per year in San Juan County waters and use vessels less than sixty-five feet in length with a United States Coast Guard certificate that limits them to fortynine passengers or less;
 - (b) Do not depart from the point of origin on a regular published schedule;
- (c) Do not operate between the same point of origin and the same intermediate stop more than four times in any month or more than fifteen times during any twelve-month period:
 - (d) Use vessels that do not return to the point of origin on the day of departure; or
 - (e) Operate vessels upon the waters of the Pend Oreille River, Pend Oreille County, Washington.

Dear Mr. Courtney:

In your October 3 e-mail to me, you asked for an informal staff opinion on whether the type of passenger ferry service that you want to provide should be regulated or exempt from regulation.

The information provided for consideration is below:

The vessel is 40 feet long and weighs approximately 8 tons;

Seating capacity is less than 30 people;

The type of service will be on-call service for a person or persons;

The vessel would be used for charter and excursion service.

Based on the information provided, staff agrees the service, you propose to start, would be exempt from commercial ferry regulation. WAC 480-51-022 exempts charter and excursion services. I have included the pertinent WAC for your information.

These informal opinions are those of the commission staff. We reserve the right to amend these opinions should circumstances change or additional information be brought to our attention. Staff's opinions cannot be considered binding on the commission should the commission be called on to make a formal determination.

Greetings All:

The Washington State Utilities and Transportation Commission (UTC) regulates all "Commercial ferry" service under RCW 81.84 and WAC 480-51.

RCW 81.84.010 Certificate of convenience and necessity required- Service initiation - progress reports

(1) A commercial ferry may not operate any vessel or ferry for the public use for hire between fixed termini or over a regular route upon the waters within this state, including the rivers and lakes and Puget Sound, without first applying for and obtaining from the commission a certificate declaring that public convenience and necessity require such operation.

WAC 480-51-020 Definitions

(1) "The term "commercial ferry" means every corporation, company, association, joint stock association, partnership and person, their lessees, trustees or receivers, appointed by any court whatever, owning, controlling, leasing, operating or managing any vessel over and upon the waters of this state."

In 1995, Engrossed Substitute HB 1922 added "excursion service" and "charter service" to the UTC's regulation of commercial ferries in RCW 81.84. The legislature placed a sunset date when UTC regulations would expire on January 1, 2001, for "excursion service" and "charter service."

The legislature defined "excursion service" and "charter service" as follows:

WAC 480-51-020 Definitions

- (13) The term "excursion service" means the carriage or conveyance of persons for compensation over the waters of this state from a point of origin and returning to the point of origin with an intermediate stop or stops at which passengers leave the vessel and reboard before the vessel returns to its point of origin.
- (14) The term "charter service" means the hiring of a vessel, with captain and crew, by a person or group for carriage or conveyance of persons or property.

What does all this mean?

WAC 480-51-022 Exempt vessels and operations, adopted by the UTC in 1995, became void January 1, 2001 when the commission's statutory authority expired. A WAC cannot overstep statutory authority provided by the legislature in RCW 81.84. The commission has not updated the rules relating to commercial ferries Chapter 480-51 since 1995. The commission does not have any authority to regulate "charter service" or "excursion service."

What is an example of "excursion service"?

1) Company XYZ leaves origin (the start of service);

2) Company XYZ makes an intermediate stop where passengers leave the boat to do whatever:

3) All passengers return and reboard the boat "before" Company XYZ returns to the original origin, which completes the service.

What is an example of "charter service"?

1) The Boy Scouts of America (a group) hires the boat, captain and crew to take the Boy Scout troop (15 boys) out fishing, swimming and to have a picnic (a common purpose).

The 15 boys board the vessel and head out for their day of fun.

3) The Boy Scouts of America pays the company one check for the 15 boys.

OR.

- 1) A person hires the boat, captain, and crew to take the person alone or a group of people with a common purpose to do something.
- 2) The person pays for the service or for the group with one check.

I hope this information clarifies the regulation, by UTC, for commercial ferry companies.

During our process of requesting public comment regarding your proposed "on-call charter boat operation" special use permit application we received many responses.


We also received an E-mailed message sent on March 31, 2008 from Penny Ingram at Washington State Utilities and Transportation Commission (WUTC). It is now the opinion of WUTC that you will need to obtain a "Certificate of Public Convenience and Necessity" to operate on Lake Chelan. National Forest special use permits contain the clause, "The holder shall comply with all applicable Federal, State, and local laws, regulations, and standards". This clause requires us to put a hold on your application process until the state regulated "Certificate of Public Convenience and Necessity" is obtained.

Thank you for clarifying that you <u>only</u> want to provide "charter service" that is under a single contract where the "charterer" has acquired the *exclusive use and control of the vessel for the term of the contract*.

In 1995, Engrossed Substitute HB 1922 added "charter service" to the UTC's regulation of commercial ferries in RCW 81.84. The legislature placed a sunset date when UTC regulations would expire on January 1, 2001, for "charter service."

The legislature defined "charter service" as follows:

WAC 480-51-020 Definitions

(14) The term "charter service" means the hiring of a vessel, with captain and crew, by a person or group for carriage or conveyance of persons or property.

It is staff's informal opinion that the commission does not have regulatory authority to regulate "charter service" as defined in WAC 480-51-020.

Staff's opinions cannot be considered binding on the commission should the commission be called on to make a formal determination.

You have not been totally clear as to the "type" of service that you want to provide on Lake Chelan.

As you know, the Washington State Utilities and Transportation Commission (UTC) regulates all "Commercial ferry" service under RCW 81.84 and WAC 480-51.

RCW 81.84.010 Certificate of convenience and necessity required- Service initiation – progress reports

(1) A commercial ferry may not operate any vessel or ferry <u>for the public use for hire</u> <u>between fixed termini or over a regular route</u> upon the waters within this state, including the rivers and lakes and Puget Sound, without first applying for and obtaining from the commission a certificate declaring that public convenience and necessity require such operation.

WAC 480-51-020 Definitions

(1) "The term "commercial ferry" means every corporation, company, association, joint stock association, partnership and person, their lessees, trustees or receivers, appointed by any court whatever, owning, controlling, leasing, operating or managing any vessel over and upon the waters of this state."

WAC 480-51-020 Definitions

(13) The term "excursion service" means the carriage or conveyance of persons for compensation over the waters of this state from a point of origin and returning to the point of origin with an intermediate stop or stops at which passengers leave the vessel and <u>reboard</u> before the vessel returns to its point of origin.

<u>Note:</u> "Excursion Service," all passengers return and reboard the boat "<u>before</u>" the boat returns to the point of "origin" (beginning) of service.

(14) The term "charter service" means the hiring of a vessel, with captain and crew, by a person or group for carriage or conveyance of persons or property.

<u>Note:</u> "Charter service" is under a single contract where the "charterer" has acquired the exclusive use and control of the vessel for the term of the contract.

Hi Penny,

Yes I'm still interested in providing boat service on Lake Chelan. I have sent a copy of my

original letter stating why this operation should be exempt and I'm not sure of the best

way to clarify it. If you could tell me which parts you believe are unclear it would help me

in trying to describe the operation.

Here are some main points I would like to add. Stehekin is an isolated community that is

dependent on water transportation for its livelihood.

There are no commercial boat businesses in Stehekin. The only permitted ferry service on

Lake Chelan is based in Chelan and its schedules are based on Chelan needs. At this time

there is no seaplane service and only one other small charter service with a small boat that

is weather dependent. For half the year the permitted ferry operator will only stop at

three docks uplake, leaving cabins, campgrounds and trailheads along the lake without

commercial service.

My proposed operation would fill in a big portion of this gap in transportation and with so

many variables in serving clients it seems it would be difficult operate as a regulated

business.

My letter writing skills are not the best so I hope I have been clear. I would like to

invite you and/or staff to visit Stehekin, I would be glad to show you around and maybe

even arrange for a community meeting to here comments from residents.
