SERVICE AGREEMENT LEACHATE MANAGEMENT PROJECT BELLINGHAM INTERNATIONAL AIRPORT Bellingham, WA

December 17, 2008

This Amendment modifies the Agreement dated October 12, 2005, between the **Port of Bellingham** and **VanderVeen Family Transport**. All provisions of the original Agreement shall apply except as follows:

I. SCOPE OF SERVICES

1. The Contractor shall furnish all identified supplies and perform all work and labor in accordance with the Agreement as defined in Division 1 of the Standard Specifications for Road, Bridge, and Municipal Construction 2004 edition.

II. TERM

1. The term of this Agreement shall be extended and in effect on a month-to-month basis beginning January 1, 2009, and ending on December 31, 2009.

III. COMPENSATION AND PAYMENT

1. Compensation is unchanged from Amendment No. 2; price per gallon shall be \$0.0162.

Total of funds expended thru August 20, 2008, is \$105,385.15.

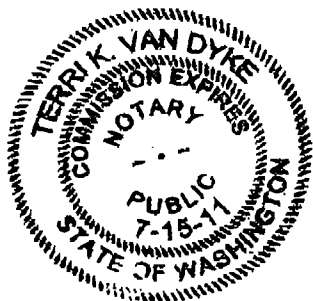

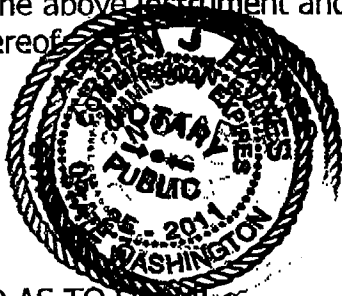
