A recent review of the Company's rate schedules in the above referenced Tariff's shows that several of these schedules are outdated. As such, the Company requests that the following schedules be cancelled (the Company has provided copies of the current tariffs for convenience).

WN U-28	52	1st Revision Sheet 52	Referenced BPA Contract Expired, and Rate of \$0.00 has been in effect since 12/1/2000
WN U-28	55	1st Revision Sheet 55	Temporary Rate Adjustment from BPA that is expired. Rate of \$0.00 that has been in effect since 1982
WN U-28	56	1st Revision Sheet 56	Schedule used to refund proceeds from sale of Centralia in 2000 and 2001.
WN U-28	61	Original Sheet 61 & Original Sheet 61A	This schedule details an older energy conservation program that has been expired since 1989. These types of programs are now administered through Schedule 90.
WN U-28	67	Original Sheet 67	This schedule details an older energy conservation program that has been expired since 1995. These types of programs are now administered through Schedule 90.
WN U-28	92	1st Revision Sheet 92 & Original Sheet 92A	This Schedule details a short-term energy buy-back program instituted in the 2001 Energy Crisis, and expired on October 12, 2001.

WN U-28	96	1st Revision Sheet 96	This schedule was used for an interim general rate increase in 2002, and effective 7/1/02, rates were set to \$0.00 for this schedule (per 5th Supplemental Order, UE-011595)
WN U-29	161	Original Sheet 161 & Original Sheet 161A	This schedule details an older energy conservation program that has been expired since 1989. These types of programs are now administered through Schedule 190.
WN U-29	163	2nd Revision Sheet 163, 1st Revision Sheet 163A, 2nd Revision Sheet 163B, 1st Revision Sheet 163C, 1st Revision Sheet 163D, & Original Sheet 163E	This schedule relates to the Company's former Natural Gas Benchmark Mechanism. This mechanism was terminated on 4/30/2004.

Also attached for filing with the Commission is the following proposed tariff revision:
