
Thank you for taking the time to help in the process of receiving licensing from the WUTC for my company.

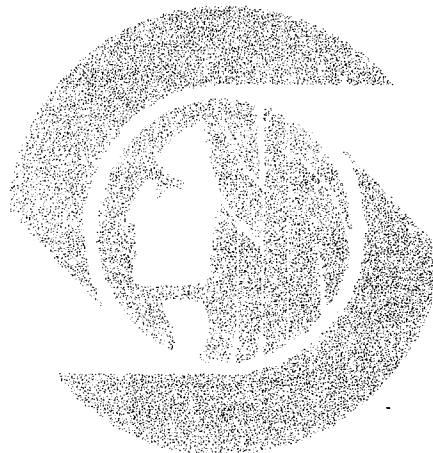
