- (1) Revise the Company's Tariff, General Rule 5, to:
 - (a) Identify the Company's practices for disconnection of service when a customer or applicant is found to have obtained service using false identification, and
 - (b) Identify the Company's practices regarding reconnection of service;

- (2) Revise the Company's Tariff, General Rule 1, to clarify the requirements for customer provided proof of identification; and
- (3) Revise the Company's Tariff, Schedule C, to clarify the language relating to service reconnection charges.
- (4) Revise various rules and rate schedules to replace the word discontinuance with the word disconnection.

The Company respectfully requests that the tariff sheets filed herein be approved to become effective with service on and after February 12, 2010.
