Re: CIMCO Communications, Inc. - Request for Cancellation of Registration

Dear Mr. Danner:

On behalf of CIMCO Communications, Inc. (now known as Cap Capital, Inc.) (the "Company"), attached for filing is the Company's Request for Cancellation of Registration. The Company is registered as a telecommunications company with competitive classification pursuant to the Order issued in Docket No. UT-971500 on November 6, 1997 (the "Authorization").

On March 16, 2010, the Company completed a transaction with Comcast Phone, LLC whereby the Company transferred all of its assets and customers to Comcast Phone, LLC and certain of its affiliates.¹ As a result of the transaction, the Company no longer provides telecommunications services in Washington. The Company, therefore, no longer requires its Authorization. Because the Company does not serve any customers or have any active telecommunications operations in Washington, the Company respectfully submits that the surrender of its Authorization is reasonable and necessary and will not be disruptive to the present or future public interest, convenience and necessity.


