Dear Secretary Danner:

Enclosed please find revised pages 2 and 37 to the above-referenced tariff for the purpose of establishing a rate for the new Bagster® 3-yard container service. The Bagster® is a woven polypropylene bag capable of handling up to 3,300 pounds. It is sold by retailers located within market areas where Waste Management can perform collection services, and comes with instructions to customers about how to verify whether they are eligible for Bagster® service. When an eligible customer contacts Waste Management, the company performs collection service using dedicated vehicles with a 16-foot boom in a box skid unit.

Waste Management, Inc. (WM) is rolling out nationwide this new solid waste service and it is currently being advertised on television. Here in Washington, we would like to introduce Bagster® 3-yard container service in our Waste Management - Northwest territory, initially. We will be including a flyer in Waste Management -Northwest customers' bills in the near future informing them of this new service pending WUTC approval. Enclosed is a sample flyer similar to the one that will be mailed.

In addition to the revised tariff pages, also enclosed is our financial analysis that estimates assumed costs to implement this new service in order to establish our tariff rate. This analysis is based on estimates using participation rates from other parts of the country where this service has been recently introduced. As a new service option that has not been previously included in our tariff, this filing is subject to seven days' notice to the Commission under WAC 480-70-272. However, we are requesting that this new rate be effective on July 1,


