Dear Mr. Danner:

Enclosed please find the original Tariff WN U-3 for CenturyTel of Cowiche d/b/a CenturyLink. This tariff replaces in entirety WN U-2 and WN U-3, as of the effective date of this filing.

This filing is submitted in compliance with Compliant with WAC 480-80-133(5). By tariff filing submitted on behalf of CenturyTel of Cowiche, effective October 19, 2009, the Company acknowledged its new fictitious name "CenturyLink" and filed a notice of adoption, where under CenturyLink adopted as its own the tariffs previously filed by CenturyTel of Cowiche d/b/a CenturyTel. CenturyTel of Cowiche d/b/a CenturyLink indicated in that filing its intention to issue a new tariff in entirety no later than October 15, 2010.

This filing is administrative in nature and the rates, terms and conditions found in this reissued tariff are identical to those contained in the current WN UN-2 and WN U-3. Therefore, the re-issuance of this tariff has no impact to existing customers.

The revisions made to the tariff include the following:

- 1) Tariff page headings are updated to reflect the company name of CenturyTel of Cowiche d/b/a CenturyLink and to reflect the new tariff number WN U-3 pursuant to WAC 480-80-101;
- 2) Section numbers have been assigned to the tariff, each tariff page is shown as an Original Page, and each Section begins with Page 1;
- 3) Various formatting to tariff pages to ensure consistent font size and outline structure are maintained throughout the document.
- 4) Certain content has been moved to preceding or subsequent page for formatting standardization;
- 5) Vacation Number Reservation and Emergency Line Service, formerly appearing at the end of WN U-2, now appears in Section 4 of WN U-3.

- 6) Material previously appearing in WN U-1 now appears as Section 12 of WN U-3.
- 7) Removal of obsolete promotional language;
- 7) Certain tariff section references are revised;
- 8) Table of Contents pages are revised to reflect new tariff page numbers;
- 9) Tariff page footers are updated to reflect the current Manager of Tariffs.

I, Debra Levy, in compliance with WAC 480-80-103, certify that I have authority to issue tariff revisions on behalf of CenturyTel of Washington, Inc. d/b/a CenturyLink.
