To whom it may concern:

Frontier Communications Northwest Inc. submits Advice No. 3311, a tariff filing in the General and Local Exchange Tariff, WN U-17, which contains proposed language in Section 10 to establish a new Utility Tax. The City of Liberty Lake City Council passed Ordinance No. 188, which established a 6% Utility Tax, with an effective date of December 26, 2010.

The Company requests permission to file the proposed provisions with less than statutory notice. The Company name change tariff (General and Local Exchange Tariff, WN U-17) filing was made effective December 23, 2010.
