Williams is an interstate pipeline. Washington State is part of Williams Northwest Pipeline; it supplies natural gas to the Pacific Northwest and Intermountain Region. It has approximately 3,900-mile bi-directional transmission system crossing the states of Washington, Oregon, Idaho, Wyoming, Utah and Colorado. Northwest's bi-directional system provides access to British Columbia, Alberta, Rocky Mountain, and San Juan Basin gas supplies.
