The primary purpose of this filing is to simplify the process by which customers apply for and satisfy the requirements for service under Schedule 150 (net metering) and Schedule 151 (production incentive). The Company proposes to accomplish these purposes by consolidating the processes into a single agreement called the Application and Agreement for Interconnection, Net Metering and/or Production Metering (the "Application and Agreement") and by moving provisions from the previously required agreements into the Application and Agreement and into Schedules 150 and 151.

The new Application and Agreement replaces the current attachments to Schedules 150 and 151 (Net Metering Agreement, Net Metering Agreement for Federal Government Agency and Renewable Energy Production Incentive Agreement). Also, many of the terms and conditions of Attachments A, D, and E (Application - 10 KW or Less, Certificate of Completion, and Interconnection Agreement - 100 KW or Less - Net Metering) to Schedule 80, General Rules and Provisions, are incorporated into Schedule 150, Schedule 151 or the Application and Agreement to further reduce the number of forms an applicant must complete. Revisions to Schedule 80 are also provided to include references to the new Application and Agreement. This filing also incorporates the recent legislation regarding community solar projects within Senate Bill 6658.

The tariff sheets described herein reflect an issue date of April 8, 2011, and an effective date of May 9, 2011. Posting of proposed tariff changes, as required by law and the Commission's rules and regulations, is being completed immediately prior to or coincident with the date of this transmittal letter through web, telephone and mail access in accordance with WAC 480-100-193. Since this filing proposes changes in terms or conditions without restricting access to service, pursuant to WAC 480-100-195(3) notice to customers will be provided in the same manner as posting is accomplished under WAC 480-100-193.
