The purpose of this filing is to submit proposed revisions to Rule 29, Terms of Distribution System Transportation Service in accordance with the Settlement Agreement that was adopted by the Commission in Order 04, Final Order Approving And Adopting Settlement Agreement in Docket No. UG-101644 (the "Settlement and Order").

The Settlement and Order provided that the PSE would modify its transportation tariff provisions to mirror Northwest Pipeline's monthly balancing and related penalty provisions and that the modification take place in a separate filing. This filing is that separate filing which the Settlement and Order provided was to be made within thirty days of the Commission's order adopting and approving the settlement agreement. The Commission issued the Settlement and Order on March 15, 2011.

In addition to changes to mirror Northwest Pipeline's monthly balancing and related penalty provisions, the provisions related to balancing upon termination have been modified to be similar to the revised

monthly balancing and penalty provisions and also provisions have been added to allow for buy out of an imbalance should a customer not be able to eliminate the imbalance through use or nomination of additional gas.

The tariff sheets described herein reflect an issue date of April 13, 2011, and an effective date of May 14, 2011. Posting of proposed tariff changes, as required by WAC 480-90-193, is being made by posting the proposed tariff sheets on the PSE web site immediately prior to or coincident with the date of this transmittal letter. Notice of proposed tariff changes, as required by law and the Commission's rules and regulations, will be given to the public at least thirty days before the originally stated effective date of the tariff change through web, telephone and mail access in accordance with WAC 480-90-195(3) by posting the proposal in accordance with WAC 480-90-193(1).
