New Tariff Book WN U-75 with Housekeeping Changes

Dear Mr. Danner:

Pursuant to Washington Law, including RCW 80.28.050, RCW 80.28.060 and WAC 480-80-121, PacifiCorp, d.b.a., Pacific Power & Light Company, (PacifiCorp or Company) submits for filing the following proposed New Tariff Book WN U-75. The Company respectfully requests that the proposed tariff revisions become effective on June 13, 2011.

A list of the tariff pages is included as Attachment B.

The purpose of this filing is to cancel the currently effective Washington tariff book WN U-74 and replace it in its entirety with WN U-75. The Company has had discussions with Commission Staff concerning this filing.

In addition to a full replacement of the entire tariff book, the filing includes a reformatted index and several housekeeping changes. A red-line version of those specific pages containing housekeeping edits is included in the filing. The housekeeping edits include the following changes:

- In Schedule 33, Schedules 95 and 96 were added to the Monthly Billing section consistent with other tariff schedules.
- In Schedule 47T, Schedules 95 and 96 were added to the Monthly Billing section consistent with other tariff schedules and reactive power charges were corrected to show the current rate approved by the Commission.
- In Schedule 48T, the On-Peak Period Demand time was corrected to show the current time period approved by the Commission.
- In Schedule 300, the sheet numbers were revised to reflect the new sheet numbers in WN U-75.
