Enclosed herewith are proposed tariff 7, pages 2,7,18,24-27,29,31, and 33-36 issued May 13, 2011 become effective July 1, 2011 for Robert J. Pellegrini d/b/a Upper/Okanogan Valley Disposal, G-21. The revisions are due to increases in business and occupation taxes, postage, fuel, wages & benefits, medical insurance and other operating expenses. Our last general rate increase was January 2007, over four years ago. The annual revenue increase, if approved by the commission, is approximately \$101,458 or 7.9% of total revenue. The change in a typical 1-can customer is approximately \$1.22 or 7.9%. In conjunction, we submit the following in regards to the revised tariff.
