Dear Mr. Danner:

On behalf of Zayo Group, LLC (“Zayo”), the successor in interest to Zayo Bandwidth, LLC (“ZB”), attached for filing is ZB’s Request for Cancellation of Registration. ZB was granted a Registration in Docket No. UT-091808 on December 17, 2009.

As described more fully in Docket No. UT-110362, ZB merged with and into Zayo, with Zayo surviving the merger. The merger was completed on June 30, 2011 and, as a result, ZB no longer exists as separate corporate entity and Zayo provides telecommunications to ZB’s customers pursuant to Zayo’s Registration granted by the Commission in Docket No. UT-110349 on April 27, 2011. Since ZB no longer exists and Zayo provides services to ZB’s customers, ZB’s Authorization should be cancelled effective immediately or as soon as the Commission can take any appropriate administrative action.


