With an estimated 807,300 (source: Port of Seattle) revenue passengers departing and arriving during the cruise ship season hotels in King county are seeking a reliable per-passenger service between their locations and the cruise ships. With the exception of hotels in the City of Tukwila (Cert no. C-01052) and those within a three-mile radius of Seatac (Cert no. C-933) no company currently holds permission for an Auto Trans style transfer. Additionally, many hotels are conscious of their commitment to sustainability and are seeking green options for their passengers. With vehicles powered by alternative energy Excalibur Limousine LLC is, by far, the most suited to this goal.



Adult fares: All fares are adult fares

Animals: Generally dogs, cats and other live animals or birds will not be carried. Exception: Service animals traveling with sight or hearing-impaired passengers will be carried free of charge. Service animals will not be permitted to occupy a seat, but must lie or stand at the feet of the passenger.

Animals: Dogs traveling with sight or hearing-impaired passengers will be carried free of charge. The dogs will be permitted to occupy a seat if the company receives prior notice, but must lie or stand at the feet of the passenger.

Intermediate application: Fares to and from intermediate points not shown will be the same as the fare to or from the next more distant station for which fares are named.

Objectionable passengers: This company reserves the right to refuse to transport persons under the influence of drugs or alcohol, or who are incapable of taking care of themselves, or whose conduct or behavior may be objectionable to other passengers. The carrier also reserves the right to refuse carriage of any materials that the carrier considers unsafe and not in the best interest of the passengers.

Round trip fares: Round trip fares will be computed at 200% percent of the price of a one-way fare.

Schedule maintenance: Carrier will not be liable for delays caused by accidents, breakdowns, bad conditions of roads, snow storms or other conditions beyond the control of the carrier and does not guarantee arrival at, or departure from, any point at any specific time.

Stopovers: Stopovers will be allowed at any point on the route within reasonable limits of the route, upon notice to the agent or bus driver.

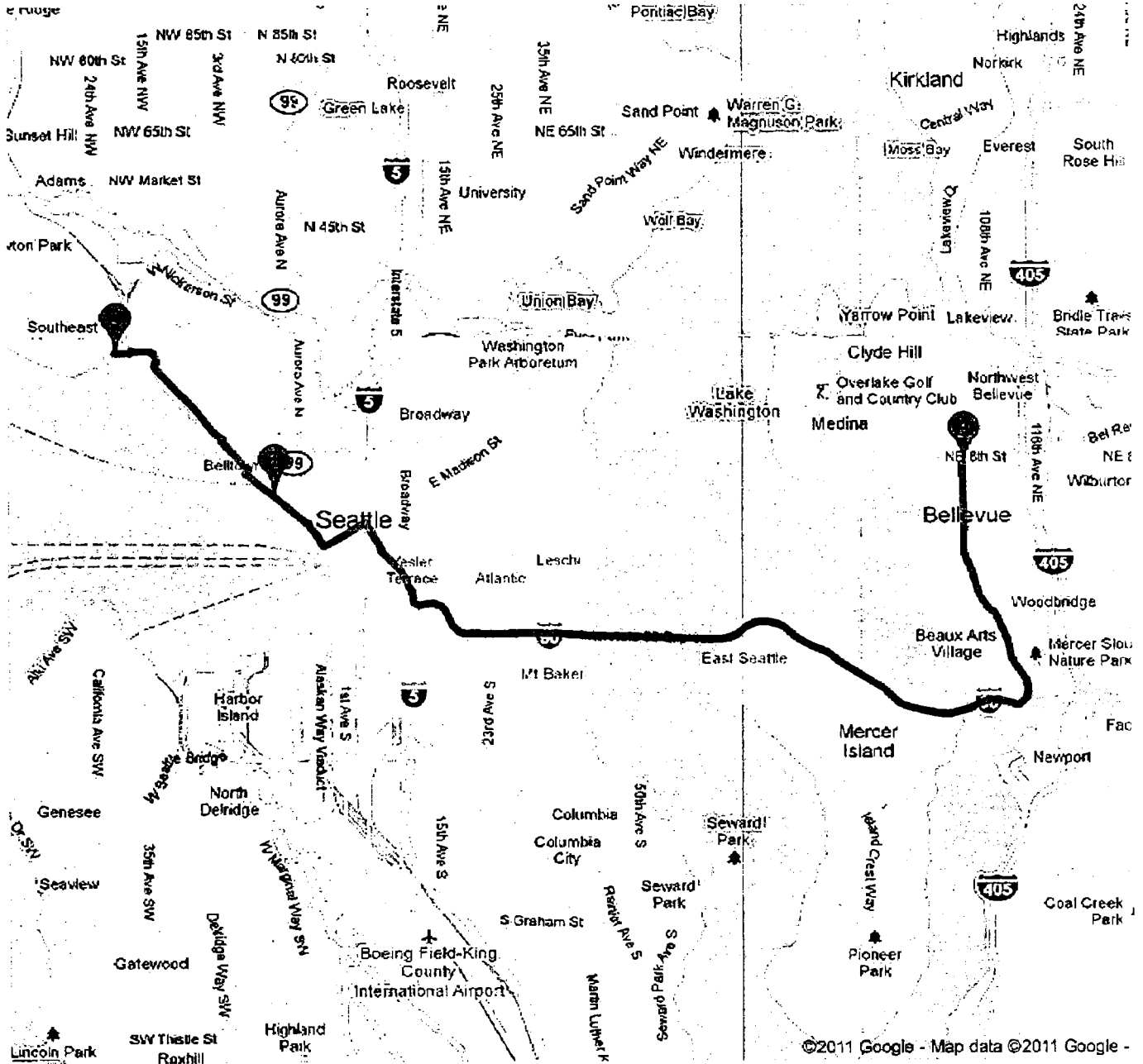

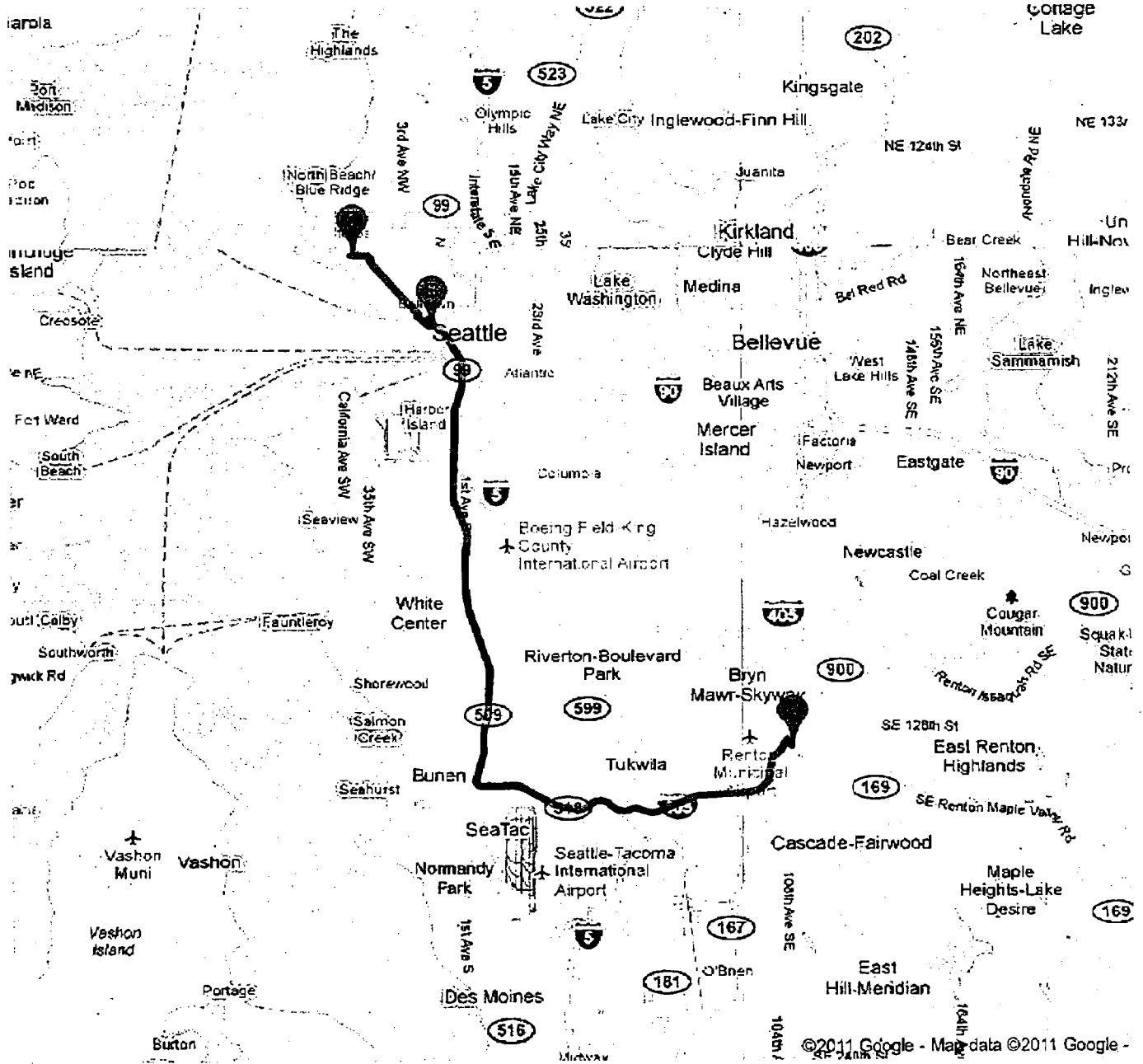

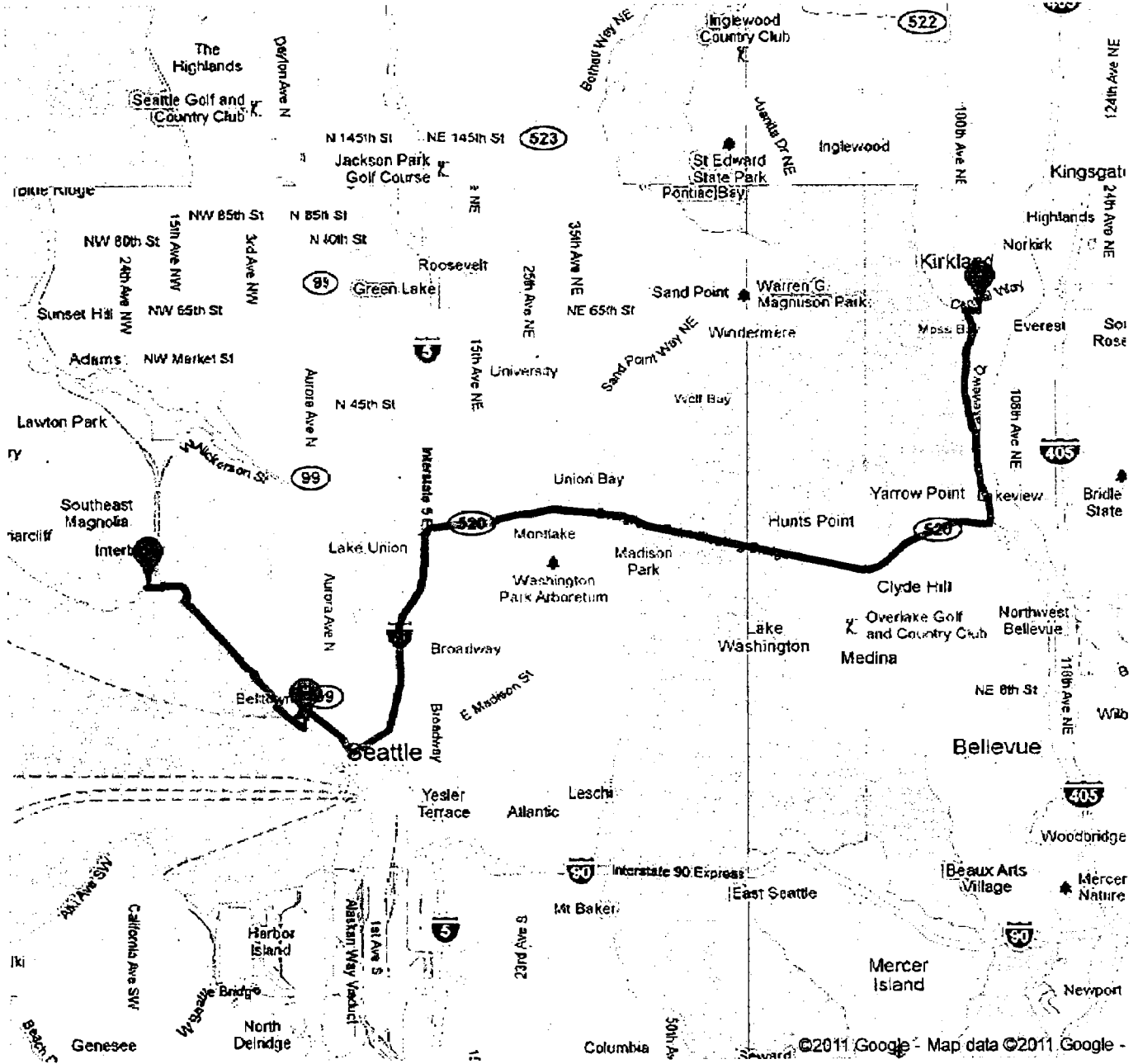
