GRADE CROSSING PROTECTIVE FUND 2011 – 2013 GRANT APPLICATION OPEN CALL FOR PROJECTS

The Washington Utilities and Transportation Commission (Commission), through its Grade Crossing Protective Fund (GCPF), provides grants for projects that eliminate or mitigate public safety hazards at railroad crossings and along railroad rights-of-way in Washington State. Any public, private or non-profit entity may submit an application to the Commission for a GCPF grant.

To apply for a grant to eliminate or mitigate a public safety hazard at a railroad crossing or along a railroad right-of-way, complete the following information and submit it and any attachments to the Commission.



There are 11 trestles and 7 public grade crossing on the 10 mile Curtis Rail Line owned by the Port of Chehalis. Fifteen (15) of the twenty-four (24) "No

Trespassing" signs that were post 5 years ago were lost in the flood events of 2007 and 2009 as well as loss due to theft and vandalism over the past few years. Additionally, the Port desires to post "No Trespassing" signs facing each direction at each public grade crossing to warn the public as to the dangers of railroad property trespass. Railroad trespass is a serious offense. Railroads are not safe lanes of travel for pedestrians. Trains and pedestrians do not mix and there is no way to warn all the public all the time except with signage. Railroad trestles along the Port owned railroad line are from 20' to 50' high and only in a couple of instances do they have guard rails. It's easy for a member of the public to trespass and fall off the trestles. Warning signage is the only way the Port can alert the public to the danger. Trespass by motorcycles and recreation vehicles results in significant damage to ballast and road bed. The signs are painted aluminum measuring approximately 18" wide by 24" high and as depicted below.



A detailed summary of the proposed project and how it will eliminate or mitigate the hazard. Include any drawings or construction plans for the proposed project.

The Port seeks funds to purchase the signs, steel posts and fasteners. The Port will either install the signs & posts with its own labor resources or request the Chehalis-Centralia Railroad & Museum to install them under our existing track and operating agreement. Signage will alert the public to the dangers of trespass of railroad tracks and trestles. Also, signage will notify the public that trespass is not just dangerous but a criminal offense.

 - a. An itemized list of the total costs (incl. sales tax) of the project.

Cost: Sign \$ 10.35 per sign

Steel post: \$ 15.86 per sign

Fasteners: \$\frac{\$ 2.00 \text{ per sign}}{2.00 \text{ per sign}}\$

b. Requirements:

Trestles: 15 signs @ \$28.21 each = \$423.15 Public Grade Crossings: 14 signs @ \$28.21 each = \$394.94 Total cost of signage for trestles and crossing = \$818.09 Cost per each crossing and trestle= \$56.42

c. Names of parties contributing to the project, including the applicant, and the amount each is contributing.

The Chehalis-Centralia Railroad & Museum or Port of Chehalis will donate volunteer labor as an "in-kind" match to install the signs at each trestle needing signage and in each direction at each public grade crossing. This is a match of approximately \$15 per sign or \$435 for the entire project. This will ensure that signs are posted a safe distance from the tracks and in the best possible location to alert the public.

The applicant will perform project inspection and verification to the UTC once the project is completed.

- 4. The name of the party responsible for long-term maintenance, such as repair of fencing. The applicant will provide future maintenance of the signage either through its own labor resources or by agreement with the Chehalis-Centralia Railroad & Museum.
- 5. An estimated timeline of the project.

Purchase signage and posts: December 1, 2011

Install signage: February 1, 2012

- 6. A description of how the project's success would be measured.

 Success of the project will be measured by correct and timely installation of warning signs to alert public to the dangers of railroad trespass.
