The Washington Movers Conference would like to petition the Washington Utilities and Transportation Commission for a change to the current Tariff No. 15-C. The changes requested would be the addition of rates in ITEM 62 – Appliance Service; ITEM 195 – Packing Charges; and ITEM 225 – Container Prices on behalf of the moving industry for the servicing and preparation for shipment of the new front load washing machines.

The recommended new rates would be as follows:

1. ITEM 62 - APPLIANCE SERVICE

The purpose for these requested changes is due to the new development and availability of the front load washing machine. The front load washing machine requires special bracing to keep the drum isolated during handling and transport between residences. This effort requires additional man time of approximately .5 hour and specialized equipment to properly secure the drum during movement of the front load washing machine.
