Enclosed for electronic filing are revisions to CenturyTel of Washington, Inc. Access Service Tariff WN U-8. These revisions are submitted with a December 16, 2011 issued date and a proposed effective date of January 16, 2012, however, CenturyLink requests less than statutory notice so that these changes may become effective on January 1, 2012.
