Please accept this Tariff and Time Schedule No. 45 for consideration. The only changes from last year are:

- (1) to the “Schedule” portion and the use of 2012 calendar dates; and
- (2) to the “Terms” portion with a change to paragraph 10 and the addition of paragraph 15. Fares remain the same as last year however we increased our bicycle charge by \$5, and we will be passing through to the travelers a Friday Harbor Port fee (\$2 pp/RT, \$1 pp/OW) that has been imposed on us by the Port of Friday Harbor. We are not taking any markup on the fee. Enclosed for your reference is a copy of the Port resolution imposing the fee should you wish to review it.
