Frontier Communications Northwest Inc. submits Advice No. 3322, a tariff filing in the General and Local Exchange Tariff, WN U-17, which contains proposed language in Sections Table of Contents, 1, 2 and 5 to comply with the Federal Communications Commission (FCC) Docket No. FCC-12-11, Lifeline and Link Up Reform and Modernization.

The following changes are effective April 1, 2012:

- 1. ETCs Federal Lifeline Support will equal \$9.25 per month for each eligible non-Tribal Lifeline subscriber, which is a 75 cent reduction in federal support; and
- 2. Link Up support will only be available to Tribal Lifeline subscribers; and
- 3. Tribal Lifeline subscribers will receive a 100 percent reduction, up to up to \$100.00, of the customary charge for commencing service.
