Liberty-Bell Telecom, LLC ("Company") files this Advice Letter No. 5 and notifies the Washington Utilities and Transportation Commission that it is changing its name to dishNET Wireline L.L.C. ("dishNET"). At the same time, it will stop operating under its trade name "DISH Network Phone & Internet." These changes will take effect on May 21, 2012.

Liberty-Bell Telecom, LLC dba DISH Network Phone & Internet was granted authority to provide facilities-based and resold local and interexchange services in Docket No. UT-100883. This change is not the result of a corporate reorganization or a change of control. There will no change in operations or to Company customers who will receive notice of the change.
