Re: Charter Fiberlink WA-CCVII, LLC's Notice of Adoption of the Interconnection Agreement between Ellensburg Telephone Company d/b/a FairPoint Communications, Inc. and 360Networks (USA) Inc., dated as of April 29, 2011, in the State of Washington

Dear Mr. Danner:

This letter serves as Charter Fiberlink WA-CCVII, LLC's ("Charter Fiberlink") notice to the Washington Utilities and Transportation Commission (the "Commission"), and associated request for approval, of Charter Fiberlink's adoption in its entirety of the Interconnection Agreement between Ellensburg Telephone Company d/b/a FairPoint Communications ("FairPoint") and 360Networks (USA) Inc. (the "Interconnection Agreement") pursuant to Section 252(i) of the Communications Act of 1934, as amended (the "Act").

In accordance with the Commission's Interpretive and Policy Statement regarding Section 252(i) of the Act,¹ Charter Fiberlink notifies the Commission that the Interconnection Agreement between FairPoint and 360Networks (USA) Inc. has an effective date of April 29, 2011 and an initial term of two (2) years. The Commission approved the Interconnection in Docket No. UT-113011 on August 15, 2011.

Charter Fiberlink is making this request because, despite notifying FairPoint of Charter Fiberlink's adoption the Interconnection Agreement on April 11, 2012, and despite repeated efforts by Charter Fiberlink to contact FairPoint regarding the adoption, FairPoint has yet to provide Charter Fiberlink with any form of an adoption letter or agreement to evidence Charter Fiberlink's adoption of the Interconnection Agreement. Section 252(i) of the Act establishes the standard for adoption of interconnection agreements. Under that section, an incumbent local exchange carrier like FairPoint

must make available any Commission-approved interconnection agreement to which it is a party to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement.² The Federal Communications Commission's rules provide that incumbents must act without "unreasonable delay" in permitting the adoption of interconnection agreements.³

Charter Fiberlink requests that the Commission approve the adoption of the Interconnection Agreement and recognize the substitution of "Charter Fiberlink" and its notice contact information below in place of those of "360Networks (USA) Inc." throughout the Interconnection Agreement:
