Present provisions are: (see Schedule #70) 25 arrivals and 25 scheduled departures to/from Sea-Tac Airport, beginning with Run #110 at 06:00am ending with Run #430 at 01:20am from Sea-Tac Airport.

Proposed changes are: (see Schedule #71) (1) Decreased and modified departures from Sea-Tac Airport from 25 to 21 by deleting Runs #122, #208, #222, #330, #426 and #430; while adding Runs #402 and #506 (2) Decreased and modified arrivals to Sea-Tac Airport from 25 to 23 by deleting Runs #121, #207, #221, #329 and #425; while adding Runs #401, #421 and #505 (3) to provide more efficient arrival times to Sea-Tac Airport with options better fit to flight times based on last 12-month period of reservations; (4) to provide more efficient return times from Sea-Tac Airport, to better fit flight arrivals based on the last 12-months of actual reservations; (5) extends service departure times from Sea-Tac Airport earlier each day from 5:50am through 12:35am.
