The purpose of this filing is to pass through a new 6% utility tax imposed on gross revenues from the sale of natural gas within the City of Spangle as specified by Ordinance No. 402. The fee is requested to become effective March 1, 2013 and will increase annual revenues by approximately \$5,000.
