Zone Telecom, Inc. was initially granted authorization as a reseller of interexchange telecommunications in Docket No. UT-001362. Zone Telecom, Inc. notified the Commission of a name change from Zone Telecom, Inc. to Zone Telecom, LLC by way of a letter of notification (see Docket No. UT-111413). Subsequent to the name change, Zone Telecom, LLC was granted an expansion of its authority to include local exchange and data services (see Docket No. UT-121838).

Please be advised that Zone Telecom, LLC ("Zone") has changed its name to ANPI Business, LLC ("ANPI Business").

Enclosed please find a copy of ANPI Business, LLC's Amended Certificate of Formation/Registration filed with the Washington Secretary of State.

ANPI Business has also provided updated regulatory contact information. The address of ANPI Business, LLC has changed, as noted in the attached contact listing. Ownership and management remains unchanged.

Based on previous interaction with the Commission, it is our understanding that Washington does not regulate VoIP services at this time. ANPI Business does intend to offer VoIP services. We will continue to monitor Washington's regulations concerning VoIP technology to insure we remain in compliance with the Commission Rules.
