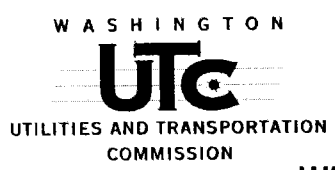




2. Omnibus Resolution.



- c) Proof that the new trade name has been registered.


For convenience, we have also attached an updated Title Page on our Tariff to indicate the new trade name information.
