Dear Mr. Danner:

Marvin Road Water Company hereby requests permission to raise its rates. The proposed rates would increase revenues to the company by \$36,845 annually for three years, for a total of \$110,536. This will increase the yearly revenue to the company by approximately 29.8%. The last rate increase for Marvin Road Water Company went into effect on April 1, 2004. These are water system Ids #72414 6, #34505 K and #31845 T, all in Thurston County.

The increase, if approved, will be used to pay for permanent repairs of a failed water distribution line, as well as repay the charges already past due on emergency temporary repairs and emergency field service. The surcharge includes the 5.029% Washington State Department of Revenue Combined Excise Tax on water company revenue and the 7.9% sales tax.

We are requesting an effective date of March 15, 2013.



Notice of Rate Increase:
Extraordinary Maintenance Expenses Surcharge

Dear Water Customer:

Marvin Road Water Company has asked the Washington Utilities and Transportation Commission for permission to increase rates by adding a new surcharge to its Tariff.

The increase, if approved, will be used to pay for permanent repairs of a failed water distribution line, as well as repay the charges already past due on emergency temporary repairs and emergency field service. The surcharge includes the 5.029% Washington State Department of Revenue Combined Excise Tax on water company revenue and the 7.9% sales tax.

If approved, the new surcharge will be effective on March 15, 2013 and expire March 15, 2016, or upon full payment of the total costs of \$110,536.

The proposed rate will be a surcharge and will be an addition to your present water bill:
