On behalf of Zayo Group, LLC ("Zayo"), the successor to AboveNet Communications, Inc. ("AboveNet"), attached for filing is the Company's Request for Cancellation of AboveNet's Registration. AboveNet was granted a Registration in Docket No. UT-980974.1

As described more fully in Docket No. UT-121999, AboveNet merged with and into Zayo, with Zayo surviving the merger.
