Dear Mr. Danner:

On behalf of Zayo Group, LLC (“Zayo”), the successor to AboveNet Communications, Inc. (“AboveNet”), attached for filing is the Company’s Request for Cancellation of AboveNet’s Registration. AboveNet was granted a Registration in Docket No. UT-980974.¹

As described more fully in Docket No. UT-121999, AboveNet merged with and into Zayo, with Zayo surviving the merger. The merger was completed on March 12, 2013 and, as a result, AboveNet no longer exists as separate corporate entity and Zayo provides telecommunications to AboveNet’s customers pursuant to Zayo’s Registration granted by the Commission in Docket No. UT-110349. Since AboveNet no longer exists and Zayo provides services to AboveNet’s customers, AboveNet’s Authorization should be cancelled effective immediately or as soon as the Commission can take any appropriate administrative action.


