On behalf of Zayo Group, LLC ("Zayo"), the successor to 360networks (USA) inc. ("360networks" and together with Zayo, the "Company"), attached for filing is the Company's Request for Cancellation of 360networks's Registration. 360networks was granted a Registration in Docket No. UT-990858.

As described more fully in Docket No. UT-121999, 360networks merged with and into Zayo, with Zayo surviving the merger.
