Dear Mr. Danner:

On behalf of Zayo Group, LLC (“Zayo”), the successor to 360networks (USA) inc. (“360networks” and together with Zayo, the “Company”), attached for filing is the Company’s Request for Cancellation of 360networks’s Registration. 360networks was granted a Registration in Docket No. UT-990858.

As described more fully in Docket No. UT-121999, 360networks merged with and into Zayo, with Zayo surviving the merger. The merger was completed on March 12, 2013 and, as a result, 360networks no longer exists as separate corporate entity and Zayo provides telecommunications to 360networks’s customers pursuant to Zayo’s Registration granted by the Commission in Docket No. UT-110349. Since 360networks no longer exists and Zayo provides services to 360networks’s customers, 360networks’s Authorization should be cancelled effective immediately or as soon as the Commission can take any appropriate administrative action.
