Northwest Natural Gas Company, dba NW Natural (NW Natural or Company), files herewith the following revisions to its Tariff WN U-6 stated to become effective with service on and after **July 1, 2013**:

Second Revision of Sheet E.6, Rate Schedule E, "Distribution Facilities Extensions For Applicant-Requested Services and Mains."

The purpose of this filing is to revise the tax effects percentage that is applied to construction contribution amounts assessed under Schedule E. This is the first time that the tax effects percentage has been updated since it became effective on January 1, 2002. The updated amount is 27.17%, an increase from the 2002 tax effects percentage of 22.859%. A workpaper showing the derivation of the updated percentage is included in support of this filing.

The Company recently realized its oversight in not updating the tax effects percentage and has now implemented processes to ensure an annual review and adjustment, if necessary. Any future revisions to this amount will be filed with the Commission so as to accommodate a January 1 effective date.

The proposed change to the Schedule E tax effects percentage does not have any revenue impact on the Company, and there is no rate impact on Washington ratepayers.

The Company respectfully requests that the tariff sheets filed herein be approved to become effective with service on and after July 1, 2013.
