Pursuant to RCW 80.28.060, WAC 480-80-101 and 105 please find enclosed for filing the following proposed revision to the WN U-60, tariff for electric service of Puget Sound Energy, Inc. (the "Company" or "PSE"):

10<sup>th</sup> Revision of Sheet No. 194 – Schedule 194 – Residential And Farm Energy Exchange Benefit

The purpose of this filing is to implement changes to rates to pass-through an increase in the benefits that PSE expects to receive under a Residential Exchange Program Settlement Agreement (the "Agreement") between PSE and the Bonneville Power Administration ("BPA"). The Agreement with BPA provides benefits to PSE's eligible residential and farm customers on rate Schedules 7, 7A, 8, 10, 11, 12, 29, 35, 56, and 59 and this filing effects an increase in the credit rate and decreased total bills to all customers on these schedules. This proposal represents the pass-through to eligible residential and farm customers of \$103,662,106 over the twelve months beginning October 1, 2013, at a credit rate of \$0.009279 per kWh.

This filing represents a \$26.1 million increase in the amount of benefits available to PSE's customers from the amount currently being credited to customers, resulting in a 2.5% or \$2.49 decrease in the total bill for a typical residential customer using 1,000 kWh per month.

The Agreement provides for allocation of benefits between investor-owned utilities based on their comparative Average System Cost ("ASC"). The filing does not change PSE's net revenue, as it is a pass-through of funds received from BPA. Work papers supporting this filing are enclosed.

The tariff sheet described herein reflects an issue date of August 30, 2013, and an effective date of October 1, 2013. Posting of proposed tariff changes, as required by law and the Commission's rules

and regulations, is being completed immediately prior to or coincident with the date of this transmittal letter through web, telephone and mail access in accordance with WAC 480-100-193.

This filing represents a bill decrease to all customers, as such notice to customers could be provided in accordance with WAC 480-100-193. However since this filing is coincident with the Company's filing increasing rates under the Low Income Program, notice will be provided jointly in accordance with WAC 480-100-194.
